Chapter 1. Installation

Installing Lineback

To install **Lineback** you must run the **Setup** program on the distribution disk. The exact method of executing the **Setup** program depends on the version and type of Windows operating system that is installed on your computer.

Copying the files from the distribution disk to your computer or executing the program from a file or application server is not sufficient to run **Lineback**. Several dynamic link libraries, such as the **Scientif** application library, and active-x controls, such as the grid control, are required for the proper execution of the **Lineback** program and must be registered on your computer. The **Setup** program copies and registers these libraries and controls during its installation process.

To remove the **Lineback** application completely and safely from your computer see the instructions in the section on Removing **Lineback**

Installation Instructions for Windows NT 4.00 and Windows 95 and Windows 98

- 1. Insert the distribution disk into the floppy or CD-ROM disk drive **d**:.
- 2. In the **Control Panel**, select **Add/Remove Programs** and then press the **Install/Uninstall** tab.
- 3. The Windows operating system will search for the installation program on the floppy or CD-ROM drive **d**: and will identify **d**:\Setup.exe as the installation program.
- 4. Press **Finish** to start the installation procedure.
- 5. Follow the instructions of the Setup program.

If your floppy or CD-ROM disk drive is not drive **d**:, substitute the appropriate disk drive letter with colon for **d**: in the above instructions.

Alternatively, you can also install **Lineback** using the installation instructions for Windows NT version 3.51.

Installation Instructions for Windows NT 3.51

- 1. Insert the distribution disk into the floppy or CD-ROM disk drive **d**:.
- 2. In the Windows Program Manager, select the **Run** command from the **File** menu.
- 3. In the Command Line box type:

d:\setup

- 4. Choose **OK** to start the installation procedure.
- 5. Follow the instructions of the Setup program.

If your floppy or CD-ROM disk drive is not drive **d**:, substitute the appropriate disk drive letter with colon for **d**: in the above command.

Installation Notes

Scientif Dynamic Link Library

Lineback uses the common **Scientif** application dynamic link library (DLL). Other programs may use the same library with the same file name *scienmfc.dll* but may require a different version of the library. We recommend that you store the *scienmfc.dll* library file included on the distribution disk in the **Lineback** application directory. This will ensure that the **Lineback** program always will use the proper version of the library, even if you install other applications that use the same **Scientif** application library.

Write Access Privileges

When installing to a Windows NT system, make sure that you have write access privileges to the directory where **Lineback** will be installed and to all the files in this directory and its subdirectories. You must also have write access privileges to the \Winnt\System32 directory. We recommend that you install **Lineback** while being logged on as administrator.

Grid Controls msflxgrd.ocx

Several commands, such as the **All Distances** command of the **Edit** menu, require that the active-x grid control *msflxgrd.ocx* is present and registered on the computer that is executing the **Lineback** program. The automated **Setup** program copies and registers the grid control during its installation process. If you run **Lineback** from a file or application server, the control must be installed on every client computer. Many commercial applications use the same grid control, so it may already be installed on your computer. To verify the presence and registration of the grid control, open the Small project, which is included on the distribution disk, and execute the **All Distances** command. If the two-dimensional distance matrix is not shown, the grid control is not installed or registered. In that case run the **Setup** program to install **Lineback** and the grid control on this computer.



Removing Lineback



You can remove the **Lineback** program and its application libraries from your computer, as well as remove its keys from the **Registry**. The exact method of removing **Lineback** depends on the version and type of Windows operating system that is installed on your computer.

Since the removal procedure actually deletes files from your computer, some of which may be system level libraries or common controls, it is strongly recommended that you make a complete backup of all the files on your computer before proceeding with the removal procedure.

To install **Lineback** on your computer see the instructions in the section on Installing **Lineback**.

Removal Instructions for Windows NT 4.00 and Windows 95 and Windows 98

Select the **Add/Remove Programs** command in the **Control Panel** of your computer. **Lineback** will be listed as one of the applications that can be automatically removed. Select **Lineback** and press **Add/Remove**. All the files specific to **Lineback**, such as the executable program file, the application help file and the **Scientif** application library, will be removed from your computer. All keys associated with **Lineback** will also be removed from the **Registry**. Common libraries, such as the Microsoft Foundation class library and the Microsoft C runtime library will not be removed. **Lineback** project files that you created in different directories will not be removed either.

Removal Instructions for Windows NT 3.51

During installation, an icon to remove **Lineback** from your computer was placed in the same program group that you selected for the **Lineback** icon. Press this **Uninstall** icon. All the files specific to **Lineback**, such as the executable program file, the application help file and the **Scientif** application library, will be removed from your computer. All keys associated with **Lineback** will also be removed from the **Registry**. Common libraries, such as the Microsoft Foundation class library and the Microsoft C runtime library will not be removed. **Lineback** project files that you created in different directories will not be removed either. Chapter 2. Tutorial

Creating a Small Tutorial Project

Following are the step by step instructions to create a small project and design its linehaul-backhaul routes in an interactive manner. For large projects it might be more convenient to create the necessary data files outside **Lineback** with a file editor capable of creating pure ASCII files and then to import the project from these data files.

Lineback follows the standard Windows graphical user interface (GUI) conventions. This tutorial will focus on the features unique to the **Lineback** program and assumes that you are familiar with the Windows environment and the execution of Windows applications. More information on the Windows user interface can be found in the Windows User's Guide.

More detailed explanations and instructions can be found in the chapters on Project Data and Design Algorithms. A summary of all the available actions in **Lineback** can be found in the section on the Command Reference. A list of traditional and WorldWide Web (WWW) references for further reading is given in the Reference section. Finally, we will be using the Small linehaul-backhaul example in this tutorial and the data for this project are summarized in the section on Sample Projects.

Steps to Be Done Before Starting A New Project

Create a project directory

Determine in which directory you want to save this new project. It is strongly recommended that you use a separate directory for each project. If necessary, create this directory on your hard drive. Note that some versions of the Windows operating environment allow you to create this directory from the **Save As** dialog box while executing the **Lineback** program. **Lineback** is compatible with long file names and long directory names.

Copy the background map file

The optional background map for a new project is imported from a map file. The default extension for a map file is *map*. Further information on the structure of the Map Data File is given in the section on **Map Data**. The map file *usa.map* contains the background map for the continental United States and has been placed in the Projects subdirectory of the **Lineback** directory during the program installation.

Copy the appropriate map file to the newly created directory. You can then later navigate to this map file from the **New Project** dialog window.

Defining a New Project

Select the **New** command from the **File** menu or press the **New** button on the toolbar. The **New** dialog window will be shown. The **New** dialog window for this project is illustrated in Figure 2.1.

Enter a project name with a maximum of 63 characters. Only letters, digits, spaces, and underscores are allowed in the project name. For this project enter Tutorial as the project name. Select a map projection method. We will be using standard x and y coordinates in this tutorial, which corresponds to an orthogonal map projection method. Determine the minimum and maximum x and y coordinates for the project and enter them in the appropriate fields. For this tutorial project the minimum and maximum x and y coordinates are 0 and 16000, respectively. Since we are using the orthogonal map projection, the minutes and seconds fields of the world coordinates are not used. Since we are using the orthogonal map projection, the world radius is not used in the project. We also will not be using a background map in this project, so we leave the map file name field blank. We will be using the straight line or Euclidean distance norm in this tutorial. Finally, enter five for the number of vehicles and enter a vehicle capacity of 400. The final **New** dialog window for this project is illustrated in Figure 2.2. Press **OK** and a new project without any facilities will be created.

Note that any data item of this project except the data items entered on the **New** dialog window can be changed later from inside the project with commands from the **File** and **Edit** menus. You will also be able to change the project name and the distance norm after the project has been created. You can get context sensitive help for any dialog window by pressing the **Help** button when the dialog windows is displayed.

The **Lineback** program shows three views of the new project in three cascaded windows. The original views are illustrated in Figure 2.3. Observe that the application title bar indicates that this is a new project that not has been saved yet. You can select the **Tile** command from the **Window** menu to display all the views simultaneously.

Each view has individual characteristics and display attributes. The type of view is indicated by an icon in the top left corner of the title bar of each view. The three view types are 1) **Project Notes** view, 2) **Algorithm Statistics** view, and 3) **Routes** view. Changing the attribute of one view does not affect the same attribute in other views.

Specifying additional project information

The project name and other project information can be changed with the **Properties** command of the **File** menu. The properties of the tutorial project are illustrated in Figure 2.4. You can also provide here additional project information and comments and they will be saved with the project.

Controlling the display of the background map

Select the **Routes** view, which will display the facilities and the routes but does not contain any facilities at this moment, by either clicking on its title bar or from the **Window** menu.

You can control the display the background map in this view by selecting the **Map** command from the **View** menu or by pressing the **Map** button on the toolbar. You can also control the display of the background map by pressing the shortcut keys **Ctrl+Shift+M**. The **Draw Map** dialog window for this tutorial project is illustrated in Figure 2.5. The possible options are None: the background map is not displayed, Outline: the boundaries of the map objects are shown only, and Area Filled: the boundaries of the map objects are shown and the objects are filled in. The default value is Area Filled. We recommend using the Outline or Area Filled modes, since the map provides visual feedback for the location of facilities. Usually, either the background map or the background grid is displayed. In this tutorial we will be using the grid, so select None to turn the display of the background map off.

Controlling the display and size of the location grid

Display the location grid in this view by selecting the **Grid** command from the **View** menu or by pressing the **Grid** button on the toolbar. You can also display the location grid by pressing the shortcut keys **Ctrl+Shift+G**.

Set the grid size for this view equal to 1000 units with the **Grid Size** command of the **View** menu. The Grid Size dialog window for this tutorial project is illustrated in Figure 2.6. Enter 1000 for the grid size. Press **OK** and only this view of tutorial project will use this new grid size. The perpendicular gridlines in this **Routes** view are now 1000 units apart.

If you have selected to display the grid in the **Routes** view, then this view is updated to reflect the new grid size.

Saving the project for the first time

Save the current project with the **Save As** command from the **File** menu. In the **Save As** dialog box, select the directory where you want to save the project file. We strongly recommend that you create a separate directory for each project before creating the new project with **Lineback**. Specify a name for the project data file, which by default has the *lineback* extension. The **Save As** dialog box for this

tutorial project is illustrated in Figure 2.7. Press the **Save** button and the file for the current project will be saved to disk.

Some versions of the Windows operating environment will truncate the default *lineback* extension to the three letters *lin*, so we recommend that you explicitly add the *lineback* extension to the file name in the Save As dialog window when saving a project for the first time.

The different views of the current project at this time are illustrated in Figure 2.8. Observe that the title bar of the application has changed from New Project to Tutorial to indicate that this project has been saved.

Adding Facilities to the Project

From the **Edit** menu, select the Add Facilities submenu and select the **Add Depot** command. The cursor will change to a crosshair shape. Move the cursor in the **Routes** view to the approximate location of the depot and click the left mouse button. The Add Depot dialog window will be displayed where you can specify additional data for this depot and refine the coordinates. The dialog window is shown in Figure 2.9.

A facility label must consist of 1 to 7 characters. Only letters, numbers, and the underscore character are allowed. A facility has to have a unique label among all facilities of that type. You have only one customer with label 1, but you can have a customer and a supplier both with label 1. The label is a required data item; i.e., it cannot be empty. The label will be used to identify the facility in all screen dialog windows.

The facility name must consist of 1 to 31 characters. Only letters, numbers, and the underscore character are allowed. The name is a required data item; i.e., it cannot be empty.

The location of the facility is given by its latitude and longitude or x and y coordinates, depending on the map projection. The latitude or the y coordinate of a facility must fall inside the world latitude or y coordinate boundaries. The longitude or the x coordinate of a facility must fall inside the world longitude or x coordinate boundaries. The world coordinate boundaries were specified when the project was created in the **New** dialog window.

Each customer has a delivery quantity and each supplier has a pickup quantity that must be carried on the vehicle. The quantity must be a non-negative integer less than or equal to the vehicle capacity.

Each facility has a geometrical symbol or shape used to display the facility in the **Routes** views. Each facility has a color used to display the facility symbol in the **Routes** views. Each facility has a size of its geometric symbol displayed in the **Routes** views.

Specify 1 for the facility label, DEP1 for the depot facility description. Define the x and y coordinates to be 6074 and 8000, respectively. Since the depot has no delivery or pickup quantity, we specify a zero quantity. Specify a square shape, a display size of 106, and a blue palette color. Press **Ok** to add this depot to the project. The number of depots in the **Notes** view is updated to indicate one depot facility. You

can only have a single depot in a project, so the **Add Depot** command is now disabled.

From the **Edit** menu, select the Add Facilities submenu and then select the **Add Customer** command. The cursor will change to a crosshair shape. Move the cursor in the **Route** view to the approximate location of the customer and click the left mouse button. The Add Customer dialog window will be displayed where you can specify additional data for this customer and refine the coordinates. The dialog window is shown in Figure 2.10.

Specify 1 for the customer label, CUS1 for the customer facility description. Define the x and y coordinates to be 409 and 9210, respectively. Specify the quantity to be 20. Specify a circle shape, a display size of 106, and a red palette color. Press **Ok** to add this customer to the project. The number of customers in the **Notes** view is updated to indicate one customer facility and total linehaul or delivery quantity is updated to 20.

From the **Edit** menu, select the Add Facilities submenu and select the **Add Supplier** command. The cursor will change to a crosshair shape. Move the cursor in the **Route** view to the approximate location of the supplier and click the left mouse button. The Add Supplier dialog window will be displayed where you can specify additional data for this depot and refine the coordinates. The dialog window is shown in Figure 2.11.

Specify 1 for the supplier label, SUP1 for the supplier facility description. Define the x and y coordinates to be 13796 and 3353, respectively. Specify the quantity to be 78. Specify a triangle shape, a display size of 106, and a green palette color. Press **Ok** to add this supplier to the project. The number of suppliers in the **Notes** view is updated to indicate one supplier facility and the total backhaul or pickup quantity is updated to 78.

At this time the project contains three facilities and you can continue adding customers and suppliers in this way. The data for all the customers, suppliers and depot is given in the appendix as the Small project. You can also import all the facilities from a set of ASCII data files.

However, the **Import** command essentially creates a new project from the ASCII data files, so you have to specify again any information that you added to the project with the **Properties** command and adjust the settings of the **Routes** view to suite your taste. You have to use again the **Save As** command to save this project for the first time and specify manually the *lineback* extension, otherwise the ASCII data in the import data file will be overwritten with the binary data.

Select the **Import** command from the **File** menu and navigate to the Project\Tutorial subdirectory of the directory where you stored the **Lineback** program. Select the file *Tutorial.dat* in this directory to import the Tutorial project with all facilities defined. The **Import** dialog window is show in Figure 2.12.

The different views of the current project at this time are illustrated in Figure 2.13. The total delivery demand of all the customers is 830 and the total pickup supply of all the suppliers is 1030.

You can display the distances between each pair of facilities with the **All Distances** command of the Edit Links submenu of the **Edit** menu. The **All Distances** dialog window will be shown, which is illustrated in Figure 2.14. The distances are computed with the distance norm you specified when the project was created or imported. In this tutorial example the Euclidean or straight-line distance norm is used.

Designing Vehicle Routes

Setting Project Algorithm Parameters and Output Log File

Several parameters apply to all computer and interactive design algorithms.

Setting the reporting level of detail and frequency of algorithm pauses

The **Report Level** controls the level of detail written to the **Output Log** file and the number of pauses during algorithm execution. There are six levels ranging from zero to five, which generate increasingly more detailed output and frequent algorithm pauses. Report level three shows the creation of all the routes without interruption. Report level four halts the algorithm after each route is created. Select the **Report Level** command from the Parameters submenu of the **Edit** menu and select level four. The Report Level dialog window is illustrated in Figure 2.15.

Vehicle routing algorithms can be classified as construction, insertion, and improvement algorithms. The construction algorithms create a set of routes based solely on the facility locations and quantities. The insertion algorithms insert the unvisited facilities into a set of existing partial routes. The improvement algorithms attempt to reduce the total length of the routes by exchanging the sequence of facilities inside a route and by swapping facilities between routes. The **Lineback** program contains a number of vehicle routing algorithms, all of which are heuristic algorithms. An algorithm is a heuristic when it is not guaranteed to find the best or optimal solution, but rather determines a high quality solution.

Specifying a Algorithm Log File

Lineback will save the results of any algorithm in a log file, if such a file has been defined for the project. To specify a log file execute the **Output Log** command from the **File** menu. The **Output Log** dialog will be shown. The Output Log dialog is illustrated in Figure 2.18. Specify the name and location of the output log file and press **Ok** to accept the new values. The output log file has by default the extension *log* and is a pure ASCII file. The amount of information written to the output log file for each algorithm depends on the Report Level.

Specifying a maximum time limit for algorithm execution

During the execution of algorithms, the program will periodically check if the algorithm has been computing longer than the allowable run time. If the limit has been exceeded, then the algorithm will be terminated and no results of the algorithms will be retained. To set the maximum amount of execution time for an algorithm, select the **Time Limit** command from the **Edit** menu. The **Time Limit** dialog window will be shown. The Time Limit dialog box is shown in Figure 2.17. Enter a limit of 120 seconds, which is more than sufficient for this small tutorial project. Press **Ok** to accept the new value.

Specifying a random number seed

Several algorithms must make random choices at certain points during their execution. For example, the simulated annealing algorithms select randomly two facilities to be tested for an exchange improvement. These random choices are made based on the next pseudo-random number. The sequence of these random numbers depends on the starting number of the sequence, which is called the seed. When started from the same state, algorithms will generated the same solution if it has been given the same seed. You can set the random number seed by executing the **Seed** command from the **Edit** menu. The **Seed** dialog will be shown. The Seed dialog is shown in Figure 2.18. Set the seed to 12345. Press **Ok** to accept the new value.

Using construction algorithms

The Nearest Neighbor algorithm is a simple and intuitive construction algorithm. The Nearest Neighbor algorithm starts each route at the depot facility and then iteratively appends the nearest unvisited customer to the route. When appending the next customer would violate the truck capacity, the algorithm switches to iteratively appending the nearest unvisited supplier to the route. When appending the next supplier would violate truck capacity, the route returns to the depot. If unvisited customers or suppliers remain and the maximum number of routes has not been reached, then a new route is started.

Select the **Nearest Neighbor** command from the Construction submenu of the **Algorithms** menu. The algorithm wilt halt after the construction of every route. Press the **Continue** button to display the next route. The views after the Nearest Neighbor algorithm has created two routes are illustrated in Figure 2.19.



Figure 2.19. Nearest Neighbor Algorithm Pause

After the algorithm has complete successfully and has created a set of routes, the statistics of the routes are shown in the **Project Notes** and **Algorithm Statistics** views. The total distance of the routes, the number of routes, and the number of routed customers and suppliers is shown. The route cost is computed as the sum of the route distance and the infeasibility penalty. The infeasibility penalty itself is the product of any quantities on the routes over the truck capacity multiplied by the infeasibility penalty factor and the quantities of any unvisited facility multiplied by the infeasibility penalty factor. If all the routes are feasible and all facilities are visited then the route cost will be equal to the route distance. The Algorithm Statistics view is illustrated in Figure 2.20. Every time you execute an algorithm, a line with the new statistics will be shown in the Statistics view. The Statistics view also records and displays the best distance and the best cost that any algorithm has determined during this session.

Using insertion algorithms

Insertion algorithms insert the facilities that are still unvisited into a set of existing partial routes. One hopes that the partial routes form a high quality initial route set. These initial partial routes are also called route skeletons or route primitives. The unvisited facilities are inserted so that the insertion cost is minimized. Insertion algorithms have to make two decisions: which facility to insert next and on which

link to insert this facility. Depending on the answer to those two questions, many different variations of insertion algorithms have been developed.

The Extreme Crossovers algorithm creates a number of partial routes with on each route a single customer and a single supplier. It matches the customer and supplier that have the largest savings if they were visited on single route instead of on separate routes. This is the same savings definition as used by Clarke and Wright in the Savings algorithm. The number of routes is equal to the minimum of the number of vehicles, the number of customers, and the number of suppliers.

$$s_{ij} = d_{i0} + d_{0j} - d_{ij} \qquad i \in \mathbf{C}, j \in \mathbf{S}$$

The typical result of this algorithm is a number of routes with very acute aperture of the covering sector and with short crossover link far away from the depot.

The Cheapest Insertion algorithm inserts the remaining unvisited facilities into the currently existing partial routes. The algorithm finds for every unvisited facility the link on the routes with the smallest insertion penalty for that facility provided the facility insertion does not make the route infeasible. It then inserts next the facility with the smallest of these insertion penalties and then updates the insertion penalties. Let F be the set of free facilities and T be the set of links on the routes, then the facility k that is inserted next is given by

$$\min_{k \in \mathbf{F}} \left\{ \min_{(i,j) \in \mathbf{T}} \left(c_{ik} + c_{kj} - c_{ij} \right) \right\}$$

The algorithm thus executes a mini-min operation.

Select the **Extreme Crossovers** command from the Construction submenu of the **Algorithms** menu to create a set of partial routes. A set of five routes each with a single customer and supplier will be created. Then select the **Cheapest Insertion** command from the Insertion submenu of the **Algorithms** menu. The remaining unvisited facilities are inserted into these routes.

Using improvement algorithms

Improvement algorithms attempt to reduce the length of the routes by changing the sequence of the facilities on a route and by exchanging facilities between routes, provided the exchanges do not make the routes infeasible. Improvement algorithms require the existence of a feasible set of routes. Depending on the number of facilities involved in the exchange and which exchange is selected, many different variations of improvement algorithms have been developed.

The Sweep algorithm creates a sweep tour by appending the facilities to the routes when they are traversed by a ray rotating around the depot. This construction algorithm is extended in a straightforward manner to the case of vehicle routing with backhauling. When a customer or supplier facility is traversed by the rotating ray, it is inserted between the most recently appended customer and supplier facility on that route. When the inserting either the next customer of supplier would violate truck capacity, then the route is terminated. If unvisited customers or suppliers remain and the maximum number of routes has not been reached, then a new route is started.

Select the **Sweep** algorithm from the Construction submenu of the **Algorithms** menu. Attempt to improve these routes with feasible intra-route exchanges by selecting the **Three Exchange** command of the Improvement submenu. Then attempt to improve these routes by feasible inter-route swaps by selecting the **Swap** command of the Improvement submenu. Finally, attempt again to improve these routes with feasible intra-route exchanges by selecting the **Three Exchange** command of the Improvement submenu.

Manually constructing a set of routes

You can also manually construct a complete set or an initial set of partial routes. The **Manual** command allows you to construct a set of feasible routes in an interactive manner. When you execute the **Manual** command, the cursor changes to a vertical arrow indicating that you can now select facilities to be added to the routes and the algorithm **Abort** button on the tool bar is enabled. You start by clicking the left button of the mouse when it is over the depot and extend the routes by clicking the left button of the mouse when the cursor is over an unvisited or free facility. If you click for the second time on the depot, then the route is closed. Once a supplier or backhaul facilities to the current route. If adding the customer or supplier would violate the vehicle capacity, then that facility is not added to the route. The algorithm terminates when either all facilities have been placed on a route or the number of routes is equal to the number of vehicles. Not all facilities have to be included on the routes when the algorithm terminates, in other word, partial routes or route primitives are allowed.

If you click again on the last facility of the current route, then this facility is removed from the route and becomes free again and the next to last facility on the route becomes the last facility. If the depot is the only facility on the route and is clicked again, then the complete route is removed. Clicking then again on the depot will make the depot the starting facility of a new route. If the removed facility was the first backhaul supplier on the route, then you can add again linehaul customers to the route.

In general, clicking on an unvisited facility adds this facility to the route if this is a feasible extension of the route and clicking on the last facility of the route removes this facility from the route. Clicking on intermediate facilities of the route has no effect.

You can stop the process of manually creating routes by pressing the **Escape** key. If the last facility on the current route is the depot then the algorithm terminates and route statistics are computed. If the last facility was not the depot, then the current route is first closed by appending the depot facility and then the route statistics are computed.

You can abort the Manual construction algorithm by pressing the **Abort** button on the toolbar, which is shown as a stop sign. The current set of routes is deleted and the algorithm statistics are not updated.

Select the **Manual Build** command from the Construction submenu of the **Algorithms** menu and create a route with a number of customers and suppliers. The statistics for the route you are building are shown in the Add Report dialog window. The views while building the routes manually are illustrated in Figure 2.21.



Figure 2.21. Manual Build Views

If you have manually created a set of partial routes, then you can select next one of the insertion algorithms to insert the remaining unvisited facilities.

Sensitivity Analysis and Evaluating Routes

You can manually modify the data with the commands of the Edit Facilities and Edit Links submenus of the **Edit** menu. To evaluate the impact of you changes you use the **Evaluate** command of the **Algorithms** menu. The Evaluate command computes the total distance of the routes and the total cost of the routes, which includes the distance and the penalties for unvisited facilities, if routes have been created. The results are displayed in the **Notes** and **Statistics** views. The Evaluate command is most frequently used after interactive editing of the distances or quantities by you or after you have dragged a facility to a new location. The Evaluate command does not create a new set of routes, but rather computes the cost of the current set of routes based on the current distances and quantities. The command also displays in a dialog window the total distance, the total cost, and the number of linehaul and backhaul facilities and quantities on each route. The Evaluate dialog window is illustrated in Figure 2.22.

The route cost is computed as the sum of the route distance and the infeasibility penalty. The infeasibility penalty itself is the product of any quantities on the routes over the truck capacity multiplied by the infeasibility penalty factor and the quantities of any unvisited facility multiplied by the infeasibility penalty factor. If all the routes are feasible and all facilities are visited then the route cost will be equal to the route distance. You can change the infeasibility penalty factor with the **Infeasibility Penalty** command on the Parameters submenu of the **Edit** menu. A more positive value of the penalty factor tends to reduce the number and size of infeasibilities such as unvisited facilities and violated truck capacities. The penalty is set by default to 1000 when the project is created.

The **Statistics View** displays the history of algorithm statistics. This view can be printed to the default printer with the **Print** command of the **File** menu. Move and size this window to suit your taste. The statistics of the different route algorithms that you have executed so far are illustrated in Figure 2.23. The corresponding **Routes** view is shown in Figure 2.24.

Using Lineback Routes in Other Windows Programs

The results of the **Lineback** design algorithms can be used in other Windows programs in basically three ways. Unless otherwise indicated, the actions described below can be executed on all three of the **Lineback** views. First, we will print the **Lineback** views to any installed printer, and then we will copy and paste **Lineback** views into other Windows applications. Finally, the current project can be send as an attachment to an electronic mail message, if you have an active mail client installed on your computer.

Printing Lineback Views

Select the printer on which you wish to print the **Lineback** views with the **Print Setup** command of the **File** menu. This command presents a **Print Setup** dialog box, where you specify the printer and its connection. This printer and these options will then be used by all subsequent **Print** operations. The same changes can also be made from the main Windows **Control Panel**. The printer must have been previously installed from the Windows **Control Panel** or **Print Manager**. The **Print Setup** dialog box is illustrated in Figure 2.25.

The **Print Setup** dialog box is a common dialog box and its exact appearance depends on the version of your Windows operating environment.

You can preview the image that will be printed by selecting the **Print Preview** command from the **File** menu. When you choose this command, the main window will be replaced with a **Print Preview** window in which one or two pages will be displayed in their printed format. The toolbar of the Print Preview window offers you options to view either one or two pages at a time; move back and forth through the document; zoom in and out of pages; and initiate a print job. The **Print Preview** dialog box is illustrated in Figure 2.26.

The **Print Preview** dialog box is a common dialog box and its exact appearance depends on the version of your Windows operating environment.

You can also directly select the view that you wish to print and then execute the **Print** command from the **File** menu. This command presents a **Print** dialog box, where you may specify the range of pages to be printed, the number of copies, the destination printer, and other printer setup options. If you press **OK** the selected view will be printed. For **Routes** views of large projects, printing such a complex view might require substantial processing times. The **Print** dialog box is illustrated in Figure 2.27.

The **Print** dialog box is a common dialog box and its exact appearance depends on the version of your Windows operating environment.

Copying and Pasting Lineback Views with the Clipboard

To paste the contents of one of the **Lineback** views in another application, select the view that you wish to paste then execute the **Copy** command from the **Edit** menu. For the **Routes** views, the section of the routes currently displayed in the view will be copied in graphical format to the clipboard. For the **Notes** and **Statistics** views, all the text, whether it is currently displayed or not, will be copied in text format to the clipboard. For the **Notes** and **Statistics** views, indicates the version of the **Lineback** program, the name of the project and the date the view was copied to the clipboard.

Select in turn the **Notes**, **Statistics**, and **Routes** view and execute the **Copy** command from the **Edit** menu. After each copy operation either activate the clipboard and verify its contents or paste the clipboard data into an application that accepts graphical data, such as Microsoft Word.

Select in turn the **Notes** and **Statistics** view and execute the **Copy** command from the **Edit** menu. After each copy operation either activate the clipboard and verify its contents or paste the clipboard data into an application that accepts text data, such as Microsoft Excel.

If you want to use a screen shot from one of the **Lineback** views, maximize this view and then capture the view with the **Alt-PrintScreen** command. For all views, the section of the routes or text currently displayed in the view will be copied in graphical format to the clipboard. No header indicating the **Lineback** version or the project data will be added to the image on the clipboard. You can use the same techniques if you want a screen shot from the main **Lineback** window as it is currently displayed. The same technique can also be used to capture images of the various dialog boxed used by **Lineback** to the clipboard. In this case, obviously the dialog box cannot and does not have to be maximized.

Select in turn the Notes, Statistics, and Route view and maximize this view. Execute the **Alt-PrintScreen** command. After each copy operation activate the clipboard and verify its contents or paste the clipboard data into an application that accepts graphical data, such as Microsoft Photo Editor.

Sending the saved project as an electronic mail attachment

You can send the current routing project as an attachment to an electronic mail message, if you have an active mail client installed on your computer. The currently saved project will be sent, so you should save the project before sending it.

Select the **Send** command from the **File** menu to activate your mail client and to send the saved version of the current project as an attachment.

A complete list of all commands is given in the Command Reference chapter. You can also find more information in the references given in the References chapter. Chapter 3. Project Data

Specifying and Editing Project Data

Project Data

Every project has a number of data items associated with for which there is only one value per project. These data items are called scalar data items.

Project Name

Every project has a name or title, assigned to it when the project is created with the **New** command or when the projected is read from an external ASCII file with the **Import** command. Both these commands are on the **File** menu. The project title should be a maximum of 63 characters and should contain only letters, digits, underscore, and space characters. The term project title is used synonymously with project name.

The project name can be changed with the **Properties** command of the **File** menu.

If the project name contains spaces, it will be exported correctly with the **Export** command, but only the segment of the name before the first space will be imported by the **Import** command. If you plan to import and export the project, you should only use underscore characters and not spaces to separate the different segments of the project name.

Map Projection

A map projection projects the three dimensional surface of the earth on the flat twodimensional surface of the map and the screen. All map projections make some approximation errors during projection. Different map projections make different errors with respect to the distance between two points and the areas of continents.

At the current time, three map projections are supported: orthogonal, Mercator, and Albers. The orthogonal projection assumes perpendicular meridians and latitude lines and assumes that the distance between two meridians is constant everywhere. The orthogonal projection is equivalent to the standard two-dimensional coordinate system. The orthogonal projection is suitable only for small areas. The Mercator projection is best suited to map situated around the equator, since it distorts distance and area significantly at regions close to the poles. The Albers projection is particularly suited for the projection of the continental United States, Western Europe, and areas at intermediate north latitudes.



In the following projection formulas, all longitudes and latitudes are expressed in degrees. The origin longitude and latitude are denoted by lon_0 and lat_0 . All points on the origin longitude have x = 0. The radius of the earth is denoted by *R* and is equal to 3955.8 miles or 6366.2 kilometers. Finally, *deg_per_rad* is the conversion factor that corresponds to the number of degrees per radians.

Mercator Projection

$$x = \frac{R \cdot (lon - lon_0)}{deg_per_rad}$$
$$y = R \cdot \ln\left(\tan\left(\frac{45 + (lat/2)}{deg_per_rad}\right)\right)$$

Albers Projection

The latitudes of the standard parallels are denoted by lat_1 and lat_2 . The standard parallels for the continental United States are typically 33 and 45 degrees North.

A number of calculations are identical for all the points in a particular Albers projection. These calculations have to be made only once for the projection.

$$n = \frac{\sin(lat_1) + \sin(lat_2)}{2}$$
$$C = \cos^2(lat_1) + 2n\sin(lat_1)$$
$$\mathbf{r}_0 = \frac{\sqrt{C - 2n\sin(lat_0)}}{n}$$

The following formulas change with the longitude and latitude of the points to be projected.

$$q = n(lon - lon_0)$$
$$r = \frac{\sqrt{C - 2n\sin(lat)}}{n}$$
$$y = r_0 - r\cos q$$
$$x = r\sin q$$

Minimum X or West Longitude

All world coordinates are bounded by a leftmost, rightmost, topmost, and bottommost value. The minimum x is the leftmost boundary value of valid coordinates if the orthogonal map projection is used. The minimum west longitude is the leftmost boundary value of valid coordinates when the Mercator or Albers map projections are used. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. However, longitudes and latitudes are stored internally in a packed integer format. Longitudes can range from -180 to +180 degrees or from -1800000 to +1800000 in the packed integer latitude/longitude format. See the section on the **Common Data Items** for further explanation on the packed integer latitude/longitude format.
Maximum X or East Longitude

All world coordinates are bounded by a leftmost, rightmost, topmost, and bottommost value. The maximum x is the rightmost boundary value of valid coordinates if the orthogonal map projection is used. The maximum west longitude is the rightmost boundary value of valid coordinates when the Mercator or Albers map projections are used. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. However, longitudes and latitudes are stored internally in a packed integer format. Longitudes can range from –180 to +180 degrees or from -1800000 to +1800000 in the packed integer latitude/longitude format. See the section on the **Common Data Items** for further explanation on the packed integer latitude/longitude format.

Minimum Y or South Latitude

All world coordinates are bounded by a leftmost, rightmost, topmost, and bottommost value. The minimum y is the bottommost boundary value of valid coordinates if the orthogonal map projection is used. The minimum south latitude is the bottommost boundary value of valid coordinates when the Mercator or Albers map projections are used. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. However, longitudes and latitudes are stored internally in a packed integer format. Latitudes can range from –90 to +90 degrees or from -900000 to +900000 in the packed integer latitude/longitude format. See the section on the **Common Data Items** for further explanation on the packed integer latitude/longitude format.

Maximum Y or North Latitude

All world coordinates are bounded by a leftmost, rightmost, topmost, and bottommost value. The maximum y is the topmost boundary value of valid coordinates if the orthogonal map projection is used. The maximum north latitude is the topmost boundary value of valid coordinates when the Mercator or Albers map projections are used. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. However, longitudes and latitudes are stored internally in a packed integer format. Latitudes can range from –90 to +90 degrees or from –900000 to +900000 in the packed integer latitude/longitude format. See the section on the **Common Data Items** for further explanation on the packed integer latitude/longitude format.

Map Data File Name

The optional background map for a new project is imported from a map file. The default extension for a map file is *map*. The map file name must conform to the requirements for long file names in Windows. Further information on the structure of the Map Data File is given in the section on **Map Data**.

Typically, all the files associated with a project are stored in a separate directory. It is most convenient to create this directory in advance and to copy the appropriate map file to this directory. You can then navigate to this map file from the **New** dialog window.

A new map for the current design project can be loaded with the **Load Map** command of the **Utilities** menu. The display of the background map is controlled by the **Map** command of the **View** menu.



If the map data file name contains spaces, it will be exported correctly with the **Export** command, but only the segment before the first space will be imported by the **Import** command. If you plan to import and export the project, you should only use underscore characters and not spaces to separate the different segments of the map data file name.

World Radius

You specify the basic distance unit for the current project by giving the radius of the earth in these units. For example, the radius of the earth is approximately 6366.2 kilometers and 3955.8 miles. If you use a distance unit different from miles or kilometers, the earth radius must least be at least one thousand of these distance units. The world radius is not used by the orthogonal map projection.

Distance Norm

When new facilities are located the distance between the various facilities is computed with a distance norm. For the orthogonal map projection, the available distance norms are rectilinear, Euclidean or Chebyshev. For the Mercator and Albers map projections, the great circle norm is used. The distance norm used with the orthogonal map projection can be changed with the **Distance Norm** command of the **Edit** menu.

Number of Vehicles

The number of vehicles available to execute routes. It is assumed that each vehicle can execute at most one route, so the number of vehicles is an upper bound on the number of routes. The number of vehicles can be changed with the **Number of Vehicles** command of the **Edit** menu.

Vehicle Capacity

The capacity of a single vehicle is expressed in units consistent with the demand and supply quantities of customers and suppliers. All vehicles are assumed to have the same capacity. The vehicle capacity can be changed with the **Vehicle Capacity** command of the **Edit** menu.

Infeasibility Penalty

The infeasibility penalty factor is multiplied by the quantities of any unvisited facilities and by the quantity on each route that exceeds the vehicle capacity to compute the total infeasibility penalty. The total infeasibility penalty is then added to the total route distance to yield the total route cost. The infeasibility penalty factor must a non-negative number. A more positive infeasibility factor induces the algorithms to create more feasible routes. The infeasibility penalty factor can be changed with the **Infeasibility Penalty** command of the **Edit** menu.

Report Level

The Report Level controls the level of detail written to the **Output Log** file and the number of pauses during algorithm execution. There are six levels ranging from zero to five, which generate increasingly more detailed output and frequent algorithm pauses.

Levels of Detail

There are six levels of detail and pauses for reporting:

- 0. NONE generates no output per algorithm and does not halt the algorithm execution. This level is used when maximum execution speed and minimal reporting is desired.
- 1. DATABASE generates one line of strictly numerical output per algorithm. No titles or headers are included. This level is primarily used to create a data base file, which can then be manipulated in a spreadsheet or statistical analysis program.
- 2. SUMMARY displays the total cost plus the algorithm run time. It is useful if you are only interested in the final results. This level of output should be used if you are interested in performing timing studies. Higher level of details corrupt timing results due to user interaction delays and graphics creation delays. The screen is not updated until the algorithm has run to its completion.
- 3. STANDARD generates the total cost for each of the algorithm components. The program runs without interruption until the complete algorithm is finished. The screen is updated periodically to show the progress of the algorithm.
- 4. EXTENDED displays the total cost during each of the algorithm modules and the run time so far. The program halts frequently to allow you to observe the algorithm progress and the screen is updated before each pause.
- 5. DEVELOP generates extremely detailed output plus a very large number of intermediate results. This mode is only useful for debugging purposes or to observe the most detailed workings of the algorithms. The output is extremely long for large problems.

The Report Level can be modified at any time with the **Report Level** command of the **Edit** menu. It can also be changed by pressing the **Report Level** button of the **Pause** dialog window, when an algorithm is paused. The algorithm will then use this new report level for the rest of its execution.

Seed

The route construction or improvement algorithms often need to make a random choice among several alternative departments. This random choice is made based on pseudo random numbers, generated from an initial seed. An algorithm will always make the same random choices if it is given the same random seed, and hence will create the same vehicle routes. The seed has to be a positive number in the range of [1,32767]. If a seed of zero is given, then the computer will pick a random seed based on the computer clock.

Time Limit

The maximum time limit is the maximum amount of time a single algorithm is allowed to execute. The time limit is expressed in seconds. Currently, the time limit is only used to terminate the exchange improvement algorithms if they have exceeded the time limit after one complete iteration, i.e. after all possible exchanges have been tested. So it is possible that the execution time of the improvement algorithm is actually larger than the time limit specified.

Number of Replications

The construction and improvement algorithms often need to make a random choice among several equivalent tour sequences. Different replications of the same algorithm can thus provide different routes. The higher the maximum number of replications, the more likely a good set of vehicle routes will be constructed. Of course, more replications require more computation time. The default number of the maximum number of replications is equal to 20. In versions of **Lineback** before 4.0, the name of this field was **Number of Iterations**.

Map Data

In **Lineback**, background maps are considered as a collection of map objects. Each map object can be thought of as a line on a paper map that can be drawn without lifting the pencil from the paper. **Lineback** describes each map object as a series of map points denoted by latitude and longitude or by x and y coordinates, depending on the map projection of the project. Latitudes and longitudes are represented in one of two formats, a packed integer numeric format: (+/-)dddmmss or a fractional format: (+/-)ddd.ffff. For example, in the packed integer format the longitude 23°20'15" W is represented as -0232015, and the latitude 35°20'43" N as 0352043. In the fractional format, the longitude 23°30' W is represented as -23.5, and the latitude 35°06' is represented as 35.10. The packed integer format of the latitude and longitude is described in more detail in the section on **Common Data Items**.

The background map for a new project is imported from a map file. The default extension for a map file is *map*. The name of this file is shown in the **Notes** view as the **Map Data File Name**. A new map for the current design project can be loaded with the **Load Map** command of the **Utilities** menu. The display of the background map is controlled by the **Map** command of the **View** menu.

Map File Format

The file format is as follows:

If no map format is specified, the default format is packed integer.

For example the file **atlanta.map** contains the 11 map objects with a total of 473 points. The first object contains 112 points, has a boundary color of OLIVE, and an area fill color of OLIVE. Valid color names are given in the section on **Common Data Items**. For example the file **usa.map** contains the 57 map objects with a total of 15702 points. The first object contains 203 points, has a boundary color of GREEN, and an area fill color of FOREST. An extract of the corresponding map data records is given next.

Common Data Items

Longitude

The location of any facility is given by its latitude and longitude if the Mercator or Albers map projections are used for the project. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. The longitude is stored in the packed integer "(+/-)dddmmss" format, that is, the last two digits indicate the seconds, the third and fourth last digit indicate the minutes, and the remaining digits indicate the degrees. Longitudes east and west of the Greenwich meridian are positive and negative, respectively. Valid longitudes are in the range from -180 to +180 degrees, which correspond to field values from -1800000 to +1800000. For example, the longitude 23°20'15" W is represented as -0232015, and the latitude 35°20'43" N as 0352043.

Latitude

The location of any facility is given by its latitude and longitude if the Mercator or Albers map projections are used for the project. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. The latitude is stored in the packed integer "(+/-)dddmmss" format, that is, the last two digits indicate the seconds, the third and fourth last digit indicate the minutes, and the remaining digits indicate the degrees. Latitudes above and below the equator are positive and negative, respectively. Valid latitudes are in the range from -90 to +90 degrees, which correspond to field values from -900000 to +900000. For example, the longitude 23°20'15" W is represented as -0232015, and the latitude 35°20'43" N as 0352043.

Color

All objects in **Lineback** can be displayed in one of the following standard colors.

Facility Data

For the following data items, each facility can have a different individual value.

Label

A facility label must consist of 1 to 7 characters. Only letters, numbers, and the underscore character are allowed. A facility has to have a unique label among all facilities of that type. You can have only one customer with label 1, but you can have a customer and a supplier both with label 1. The label is a required data item; i.e., it cannot be empty. The label will be used to identify the facility in all screen dialog and view windows.

Name

The facility name must consist of 1 to 63 characters. Only letters, numbers, the underscore and space characters are allowed. The name is a required data item; i.e., it cannot be empty.

If the facility name contains spaces, it will be exported correctly with the **Export** command, but only the segment before the first space will be imported by the **Import** command. If you plan to import and export the project, you should only use underscore characters and not spaces to separate the different segments of the facility name.

Latitude

The location of the facility is given by its latitude and longitude or x and y coordinate, depending on the map projection. Longitudes and latitudes are displayed



and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. The latitude is stored in the packed integer (+/-)dddmmss format. For example, the longitude 23°20'15" W is represented as - 0232015, and the latitude 35°20'43" N as 0352043. Latitude and longitude in the packed integer format are described in more detail in the section on **Common Data Items**. The latitude or the y coordinate of a facility must fall inside the world latitude or y coordinate boundaries, specified when the project was created.

Longitude

The location of the facility is given by its latitude and longitude or x and y coordinate, depending on the map projection. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. The longitude is stored in the packed integer (+/-)dddmmss format. For example, the longitude 23°20'15" W is represented as - 0232015, and the latitude 35°20'43" N as 0352043. Latitude and longitude in the packed integer format are described in more detail in the section on **Common Data Items**. The longitude or the x coordinate of a facility must fall inside the world longitude or x coordinate boundaries, specified when the project was created.

Quantity

Each customer has a delivery quantity and each supplier has a pickup quantity that must be carried on the vehicle. The quantity must be a non-negative integer less than or equal to the vehicle capacity. The quantity data field for depot facilities is not used and typically set to zero.

Display Symbol

The geometrical symbol or shape used to display the facility in the **Routes** views. A list of all valid symbol names is given in the **Display Symbols** section of the **Common Data Items**.

Display Color

The color used to display the facility symbol in the **Routes** views. A list of valid color names is given in the **Color** section of the **Common Data Items**.

Display Size

The size of the geometric symbol displayed in the Routes views.

Importing Data Files from Previous Versions

The current version of the **Lineback** program can import data files created by the previous versions of the **Lineback** program with the **Import** command of the **File** menu. The description of the data files for this previous version of **Lineback** is given next.

A project is completely described by five files. A sixth file contains the optional map data. The first file is the **Project Data** file that holds all the scalar information about this project. The second through fourth files are the **Facility Data** files that contain all the data for the customer, depot, and supplier facilities, respectively. The optional fifth file contains all the data for the current set of routes. The fifth file is not required if no routes are currently defined in the project. The sixth file contains the data for the optional background map and is not required.

Project Data File

The Project Data file can be created with any editor or word processor capable of generating pure ASCII files. Word processors usually insert special formatting codes into their regular document files, such as page breaks, which cannot be read by the **Lineback** program, so special care should be taken when using a word processor to generate a pure ASCII file. The project file also should not contain any blank lines. Once an input file has been created, it can be used repeatedly by the **Lineback** program.

Each line in the input file is associated with a single data item and contains two fields. The first field is the description or name of the data item. The name of the item is enclosed in square brackets and may not contain any spaces. The second field is then the value of the item to be used. The two fields are separated by one or more space or tab characters. For example:

Project Name

The first item is the name of the current project. This name should be a maximum of 15 characters and should contain only letters, digits, and underscore characters. In the version 4.0 of **Lineback** or higher the size of this data field has been expanded and space characters are allowed, however the smaller size and no space characters should be used in the import files.

Customer File Name Supplier File Name Depot File Name Route File Name

The next items are the names of the customer, supplier, depot, and route data files, respectively. They contain all the data for facilities of that respective type or for the routes. The file names must satisfy the Windows long file name conventions. A path must precede the file name if it is not in the current directory or in the data path. Long file names may be used, but the file name and the path cannot contain spaces. An example of a customer data file is the file *Case5180.sup* that holds the supplier

information. This file is included in the appendix and on the distribution disk. The files must be created outside the **Lineback** program with an editor capable of generating pure ASCII files. The extensions *cus, sup, dep* and *rou* are solely a convention, other extensions may be used.

Seed

The tour construction or improvement algorithms often need to make a random choice among several alternative departments. This random choice is made based on pseudo random numbers, generated from an initial seed. An algorithm will always make the same random choices if it is given the same random seed, and hence will create the same vehicle routes. The seed has to be a positive number in the range of [1,32767]. If a seed of zero is given, then the computer will pick a random seed based on the computer clock.

Tolerance

At the current time the tolerance parameter is not used in the program.

Time Limit

The maximum time limit is the maximum amount of time a single algorithm is allowed to execute. The time limit is expressed in seconds. Currently, the time limit is only used to terminate the exchange algorithms if they have exceeded the time limit after one complete iteration, i.e. after all possible exchanges have been tested. So it is possible that the execution time of the improvement algorithm is actually larger than the time limit specified.

Number of Iterations

The construction and improvement algorithms often need to make a random choice among several equivalent tour sequences. Different replications of the same algorithm can thus provide different tours. The higher the maximum number of replications, the more likely a good set of vehicle routes will be constructed. Of course, more replications require more computation time. The default number of the maximum number of replications is equal to 20. In version 4.0 or higher of **Lineback**, the name of this field has been changed to **Number of Replications**.

Report Level

Report level is the level of detail the program will use in generating output reports. There are six levels of detail, ranging from 0 through 5. The higher the report level the more information is written to the Output Log File and the more frequent halts during program execution.

Facility Data Files

The Facility Data files can be created with any editor or word processor capable of generating pure ASCII files. Word processors usually insert special formatting codes into their regular document files, such as page breaks, which cannot be read by the **Lineback** program, so special care should be taken when using a word processor to generate a pure ASCII file. The facility data files also should not contain any blank lines. Once an input files have been created, they can be used repeatedly by the **Lineback** program.

All facility data files have the same structure. The customer, depot, and supplier facility data are contained in a file with standard extension *cus*, *dep*, and *sup*,

respectively. They contain all the data for a single facility on a single line, which contains eight data fields. The fields contain the facility label, x coordinate, y coordinate, quantity, display shape, display size, display color, and facility name, respectively. A typical facility data line is shown below.

Routes Data File

The Routes Data file contains a block of data lines for each currently defined route. The first line of each route block contains the number of customers on the route, the number of suppliers on the route, and the display color of the route. The lines after that contain the facilities on this route. Each route has to start with the depot facility and has to terminate with the depot facility. After the initial depot facility, all the customer facilities are listed followed by all the supplier facilities. A route may not have any customers or not any suppliers, but must include at least one facility different from the depot. For each facility the facility type and the facility label are given. The number of lines for the customer and supplier facilities has to match the number of customers and suppliers specified on the first line. A typical set of data lines for a single route is shown below.

Chapter 4. Design Algorithms

Introduction

Algorithm Taxonomy

Exact versus Heuristic

Algorithms are called optimal or exact if they find the optimal solution, algorithms are called heuristics if they attempt to find a high quality but not necessarily optimal solution.

Construction versus Improvement

Algorithms are called constructive (construction algorithms) if they create a solution from the original data without requiring an initial feasible solution. The vehicle routing construction algorithms create a set of routes based solely on the facility locations and quantities. Algorithms are called improving (improvement algorithms) if they require an initial feasible solution and attempt to improve the quality of this solution. The vehicle routing improvement algorithms attempt to reduce the total length of the routes by exchange the sequence of facilities inside a route and by swapping facilities between routes.

The vehicle routing insertion algorithms insert the unvisited facilities into a set of existing partial routes. The **Lineback** program contains a number of vehicle routing algorithms, all of which are heuristic algorithms.

Primal versus Dual

Algorithms are called primal if they maintain the feasibility of their solution while they attempt to reach optimality. Algorithms are called dual if they maintain optimality of their solution, while they attempt to reach feasibility. Typically dual algorithms ignore one or more constraint sets or sets of facilities, solve the resulting problem to optimality, and then attempt to add the ignored constraints or facilities while maintaining optimality of the current solution with respect to the current constraints.

Construction Algorithms

Nearest Neighbor

The Nearest Neighbor algorithm starts each route at the depot facility and then iteratively appends the nearest unvisited customer to the route. When appending the next customer would violate the truck capacity, the algorithm switches to iteratively appending the nearest unvisited supplier to the route. When appending the next supplier would violate truck capacity, then the route returns to the depot. If unvisitied customers or suppliers remain and the maximum number of routes has not been reached, then a new route is started.

This algorithm was originally described by Rosenkrantz et al. (1977) for the traveling salesman problem and is extended in a straightforward manner to the case of linehaul-backhaul vehicle routing.

Sweep

The Sweep algorithm creates a sweep route by appending the points to the tour when they are traversed by a ray rotating around the depot. The relative polar coordinates of each point with respect to the depot are determined and the points are inserted in the route by increasing polar angle. The algorithm was first described by Gillet and Miller (1974) for the vehicle routing problem. The starting angle of the ray is an algorithm parameter.

This algorithm is extended in a straightforward manner to the case of vehicle routing with backhauls. When a customer or supplier facility is traversed by the rotating ray, it is inserted between the most recently appended customer and supplier facility on that route. When the inserting either the next customer of supplier would violate truck capacity, then the route is terminated. If unvisited customers or suppliers remain and the maximum number of routes has not been reached, then a new route is started.

Clarke and Wright Savings Heuristic

Clarke and Wright (1964) developed a construction procedure that extends a partial route or route primitive at its two end points. Conceptually the algorithm defines the depot as the base point and constructs an Eulerian tour that visits each of the other customer or supplier points and the returns to the depot base point. The Eulerian tour is then reduced in length by finding and executing the shortcut with the largest savings. The savings are computed as the sum of the distances to the base point of the two points minus the distance between the two points.

Once two points have been joined by a shortcut they are never separated again by the Clarke and Wright algorithm. This equivalent to extending the partial route at its end points, which are connected to the base point. The next point is then selected by finding the point with the largest savings shortcut to the current end points of the partial tour.

Algorithm 4.1 Clarke and Wright Savings Algorithm (VRP Version)

- 1. Start a new tour at the depot
- 2. Construct a tour primitive by finding the two points with the largest savings shortcut
- 3. While not all points have added to the partial tour
- 4. Update computation of savings of combining tours
- 5. Append point with largest savings shortcut to endpoints of the partial tour

This algorithm was adapted to the vehicle routing problem with backhauls by Deif and Bodin (1984). Once a partial tour contains both customer and suppliers, customers can only be added between the customer end point and the depot and suppliers can only be added between the supplier end point and the depot. Deif and Bodin delayed the crossover shortcut between customers and suppliers by reducing the savings of establishing a short cut between a customer and supplier by the product of a savings penalty factor α multiplied by the largest savings of any points *S*. This savings penalty factor is an algorithm parameter set by the user. Deif and Bodin found that a good value for the savings penalty factor is 0.25

Partial Routes Construction Algorithms

The objective of partial routes construction algorithms is to create a number of routes that may not visit all the facilities but that are of high quality. The remaining unvisited facilities are then inserted into these routes. The partial routes are also called route skeletons or route primitives. Examples of similar partial tours for the Traveling Salesman problem are the convex hull and extreme point quadrilateral.

Extreme Crossovers

The Extreme Crossovers algorithm creates a number of partial routes with on each route a single customer and a single supplier. It matches the customer and supplier that have the largest savings if they were visited on single route instead of on separate routes. This is the same savings definition as used by Clarke and Wright in the Savings algorithm. The number of routes is equal to the minimum of the number of vehicles, the number of customers, and the number of suppliers.

The typical result of this algorithm is a number of routes with very acute aperture of the covering sector and with short crossover link far away from the depot.

Insertion Algorithms

Insertion algorithms insert the facilities that are still unvisited into a set of existing partial routes. One hopes that the partial routes form a high quality route set. These initial partial routes are also called route skeletons and route primitives. The unvisited facilities are inserted so that the insertion cost is minimized. They have to make two decisions: which facility to insert next and on which link to insert this facility. Depending on the answer to those two questions, many different variations of insertion algorithms have been developed.

Cheapest Insertion

The Cheapest Insertion algorithm inserts the remaining free facilities into the currently existing partial routes. The algorithm finds for every free facility the link on the routes with the smallest insertion penalty for that facility, provided the insertion would not make the route infeasible. It then inserts next the facility with the smallest of these insertion penalties and then updates the insertion penalties. Let F be the set of free facilities and T be the set of links on the routes, then the point k that is inserted next is given by

The algorithm thus executes a mini-min operation.

Priciest Insertion

The Priciest Insertion algorithm inserts the remaining free facilities into the currently existing partial routes. The algorithm finds for every free facility the link on the routes with the smallest insertion penalty for that facility, provided the insertion would not make the route infeasible. It then inserts next the facility with the largest of these insertion penalties and then updates the insertion penalties. Let F be the set of free facilities and T be the set of links on the routes, then the point k that is inserted next is given by

The algorithm thus executes a maxi-min operation.

Improvement Algorithms

Introduction

Improvement algorithms attempt to reduce the length of the routes by changing the sequence of the facilities on a route and by exchanging facilities between routes, provided the exchanges do not make the routes infeasible. Improvement algorithms require the existence of a feasible set of routes. Depending on the number of facilities involved in the exchange and which exchange is selected, many different variations of improvement algorithms have been developed.

Improvement Heuristic Classification

Exchange improvement heuristics can be divided into four classes depending on which exchange they test for possible improvement and which exchange they select to execute. For a minimization problem, such as the TSP, where we want to a tour with the lowest possible length, the categories are

- First Descend
- Steepest Descend
- Simulated Annealing
- Tabu Search

First Descend

All possible edge exchanges that can result in new routes are examined in a structured way until an exchange is found that reduces the route length. This exchange is executed immediately and the process of examining all possible exchanges starts all over. Hence, the first exchange in each iteration that yields a length reduction is executed. The process terminates when no further exchanges can be found that yield a cost reduction.

Steepest Descend

All possible edge exchanges that can result in new routes are examined in a structured way and the exchange that yielded the largest reduction in the route length is retained. If this exchange reduces the route length then it is executed and the process of examining all possible exchanges starts all over. Hence, the exchange that yields the strongest reduction in each iteration is executed. The process terminates when no further exchanges can be found that yield a cost reduction.

Simulated Annealing

Both previous improvement algorithms are deterministic, i.e. each algorithm will convert an initial set of routes into specific final set of routes. Since they are heuristics, this final set may not be of high quality. To remedy this problem, a probabilistic exchange improvement algorithm was developed. There exists an analogy between the optimization method of simulated annealing and the laws of thermodynamics, specifically with the way in which liquids freeze and crystallize or metals cool and anneal.

The simulated annealing algorithm selects a set of facilities for exchange evaluation at random. If the exchange yields a cost reduction, then the exchange is executed immediately. If the exchange yields a cost increase, then the exchange is executed with probability P, which is computed in function of the cost increase Δ and the temperature T. T is a search control parameter that is systematically reduced during the algorithm execution.

This allows early on exchanges with large cost increases. As the temperature is reduced, the number of such exchanges and the size of the allowed cost increases are gradually reduced. The objective of these non-improving exchanges is to avoid a first descend into a local minimum. The process repeats itself until no further improvements can be made. Since the exchanges were selected at random, the improvement algorithm may generate a different final route set if run from the same initial route set if different seeds are used to generate different pseudo-random number streams for sampling the probability function of P.

For further information on two and three exchanges see Goetschalckx (1992). For further information on simulated annealing see Kirkpatrick et al. (1983) and Vechi and Kirkpatrick (1983).

Computational processing time increases sharply with the amount of improvement processing.

2-Opt Exchange

The 2-opt Exchange is an intra-route edge-exchange improvement procedure that operates on a single route at the time. It attempts the change the sequence of the facilities in a route so that the route length is reduced by removing two links of the route and replacing them with two other links that connect the route again. All pairs of links that would yield a feasible exchange are tested and the exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms. An exchange is infeasible if it would violate the precedence constraint that all deliveries to customers have to be made before any pickup from a supplier can be made. A two exchange is illustrated in Figure 4.2.

3-Opt Exchange

The 3-opt Exchange is an intra-route edge-exchange improvement procedure that operates on a single route at the time. It attempts the change the sequence of the facilities in a route so that the route length is reduced by removing three links of the route and replacing them with three other links that connect the route again. All triplets of links that would yield a feasible exchange are tested and the exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms. An exchange is infeasible if it would violate the precedence constraint that all deliveries to customers have to be made before any pickup from a supplier can be made. A three exchange is illustrated in Figure 4.3.

Or-Opt Exchange

The Or-opt Exchange is an intra-route edge-exchange improvement procedure that operates on a single route at the time. It attempts the change the sequence of the facilities in a route so that the route length is reduced by removing a section or chain of the route and inserting this chain in a different place on the route. Moving a chain involves deleting three links of the route and replacing them with three other links that connect the route again. The number of facilities on the chain is called the length of the chain and is a parameter that you can specify. All chains of a certain length that would yield a feasible exchange are tested and the exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms. Since the Or-exchange involves removing three links and substituting them with three other links, all chain exchanges of all lengths will also be tested by the three-exchange procedure. An exchange is infeasible if it would violate the precedence constraint that all deliveries to customers have to be made before any pickup from a supplier can be made. A chain exchange with chain length of two is illustrated in Figure 4.4.

Move Facility

The Move Facility procedure attempts to reduce the combined length of all the routes by moving a single facility from one route to another, provided the resulting routes remain feasible. A route can become infeasible if either the linehaul or backhaul quantity exceeds the truck capacity or if the precedence constraint is violated that states that all deliveries to customers have to be made before any pickup from a supplier can be made. All move exchanges are tested and the move exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms.

Swap Facility

The Swap Facility procedure attempts to reduce the combined length of all the routes by moving one facility from one route to another and simultaneously move one facility from the second route to the first route, provided the resulting routes remain feasible. A route can become infeasible if either the linehaul or backhaul quantity exceeds the truck capacity or if the precedence constraint is violated that states that all deliveries to customers have to be made before any pickup from a supplier can be made. All swap exchanges are tested and the swap exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms.

Evaluation Algorithms

Evaluate

The Evaluate algorithm computes the length and the cost of the current routes. The Evaluate algorithm does not create new routes, but rather computes the length and the cost of the current routes based on the current distances, supply and demand data, number of vehicles and vehicle capacity, and infeasibility penalty. This algorithm is most frequently used to evaluate the impact of the changes you have made after you have edited interactively the distances, the facility, or the vehicle data.

Several commands have shortcut keys so that you can easily control the program from the keyboard. Several commands are also shown on the toolbar, to allow easy program control with the mouse.

File Menu

The **Lineback** program requires the project data before any algorithm can be executed. The projects are managed with the commands on the **File** menu.

New

The **New** command of the **File** menu allows you to interactively create a new vehicle routing design project.

If there is a project currently open and if it has been modified, then the program will display the **Save Changes** dialog window and ask if you wish to save those changes, discard the changes, or if you wish to abort the creation of new project. The **Save Changes** dialog window is illustrated in Figure 5.3.

The command displays the **New** dialog window, which is illustrated in Figure 5.4. To save the new project use the **Save As** command. To open a previously saved project use the **Open** or **Import** commands.

To create the new project with the values shown in the dialog window press the **OK** button. When this project is created it has no facilities or routes. If you press **Cancel**, no new project will be created.

Information on the individual data fields is given in **New Project Data Items** and information on the general function of the command is given in **New** command of the **File** menu.

New Project Data Items

Project Name

The project name or title refers to the title of the project to be used in reports and printouts. It consists of a maximum of 63 alphanumeric, space, or underscore characters. Punctuation marks, or tab characters are not allowed. The title is also included in the project **Properties**. The term project title is used synonymously with project name.

Further information can be found in the Project Data section under **Project Name**. The project name can be modified with the **Properties** command of the **File** menu.

Map Projection

At the current time, three map projections are supported: orthogonal, Mercator, and Albers. The orthogonal projection assumes perpendicular meridians and latitude lines and assumes that the distance between two meridians is constant everywhere. The orthogonal projection is equivalent to the standard two-dimensional coordinate system. The orthogonal projection is suitable only for small areas. The Mercator projection is best suited to map situated around the equator, since it distorts distance and area significantly at regions close to the poles. The Albers projection is particularly suited for the projection of the continental United States, Western Europe, and areas at intermediate north latitudes.

Further information can be found in the Project Data section under **Map Projection**. The map projection cannot be changed once a project has been created or imported.

Minimum X or West Longitude

The minimum x is the leftmost boundary value of valid coordinates if the orthogonal map projection is used. The minimum west longitude is the leftmost boundary value of valid coordinates when the Mercator or Albers map projections are used. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. However, longitudes and latitudes are stored internally in a packed integer format. Longitudes can range from -180 to +180 degrees or from -1800000 to +1800000 in the packed integer latitude/longitude format.

Further information can be found in the Project Data section under **Minimum X or West Longitude**. The minimum x or west longitude cannot be changed once a project has been created or imported.

Maximum X or East Longitude

The maximum x is the rightmost boundary value of valid coordinates if the orthogonal map projection is used. The maximum west longitude is the rightmost boundary value of valid coordinates when the Mercator or Albers map projections are used. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. However, longitudes and latitudes are stored internally in a packed integer format. Longitudes can range from -180 to +180 degrees or from -1800000 to +1800000 in the packed integer latitude/longitude format.

Further information can be found in the Project Data section under **Maximum X or East Longitude**. The maximum x or east longitude cannot be changed once a project has been created or imported.

Minimum Y or South Latitude

The minimum y is the bottommost boundary value of valid coordinates if the orthogonal map projection is used. The minimum south latitude is the bottommost boundary value of valid coordinates when the Mercator or Albers map projections are used. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. However, longitudes and latitudes are stored internally in a packed integer format. Latitudes can range from –90 to +90 degrees or from -900000 to +900000 in the packed integer latitude/longitude format.

Further information can be found in the Project Data section under **Minimum Y or South Latitude**. The minimum y or south latitude cannot be changed once a project has been created or imported.

Maximum Y or North Latitude

The maximum y is the topmost boundary value of valid coordinates if the orthogonal map projection is used. The maximum north latitude is the topmost boundary value of valid coordinates when the Mercator or Albers map projections are used. Longitudes and latitudes are displayed and edited in three different fields, corresponding to the degrees, minutes, and seconds of the longitude and latitude. However, longitudes and latitudes are stored internally in a packed integer format. Latitudes can range from –90 to +90 degrees or from –900000 to +900000 in the packed integer latitude/longitude format.

Further information can be found in the Project Data section under **Maximum Y or North Latitude**. The maximum y or north latitude cannot be changed once a project has been created or imported.

World Radius

You specify the basic distance unit for the current project by giving the radius of the earth in these units. For example, the radius of the earth is approximately 6366.2 kilometers and 3955.8 miles. If you use a distance unit different from miles or kilometers, the earth radius must least be at least one thousand of these distance units. The world radius is not used by the orthogonal map projection.

Further information can be found in the Project Data section under **World Radius**. The world radius cannot be changed once a project has been created or imported.

Map Data File Name

The optional background map for a new project is imported from a map file. The default extension for a map file is *map*. The map file name must conform to the requirements for long file names in Windows. Further information can be found in the Project Data section under **Map Data File Name**. Further information on the structure of the Map Data File is given in the section on **Map Data**.

Typically, all the files associated with a project are stored in a separate directory. It is most convenient to create this directory in advance and to copy the appropriate map file to this directory. You can then navigate to this map file from the **New** dialog window.

A new map for the current design project can be loaded with the **Load Map** command of the **Utilities** menu. The display of the background map is controlled by the **Map** command of the **View** menu.

Distance Norm

When new facilities are located the distance between the various facilities is computed with a distance norm. For the orthogonal map projection, the available distance norms are rectilinear, Euclidean or Chebyshev. For the Mercator and Albers map projections, the great circle norm is used.

Further information can be found in the Project Data section under **Distance Norm**. The distance norm used with the orthogonal map projection can be changed with the **Distance Norm** command of the **Edit** menu.

Number of Vehicles

The number of vehicles available to execute routes. It is assumed that each vehicle can execute at most one route, so the number of vehicles is an upper bound on the number of routes. Further information can be found in the Project Data section under **Number of Vehicles**. The number of vehicles can be changed with the **Number of Vehicles** command of the **Edit** menu.

Vehicle Capacity

The capacity of a single vehicle is expressed in units consistent with the demand and supply quantities of customers and suppliers. All vehicles are assumed to have the same capacity. Further information can be found in the Project Data section under **Vehicle Capacity**. The vehicle capacity can be changed with the **Vehicle Capacity** command of the **Edit** menu.

Open

The **Open** command of the **File** menu allows you to read a previously saved project.

The program will read the corresponding **Project Data File**. Starting with version 4.0 of the **Lineback** program, the **Project Data File** is a binary file that can no longer be viewed or manipulated outside the **Lineback** program. Use the **Import** command to import project data created with previous versions of the **Lineback** program or with the **Export** command. The default extension for **Lineback** project files is *lineback*. The command then displays the **Open** dialog window, which is illustrated below in Figure 5.5.

Close

The Close command of the File menu allows you to close the current project.

If the current project has been modified, then the program will display the **Save Changes** dialog window and ask if you wish to save those changes, discard the changes, or if you wish to abort the closing of the current project. The **Save Changes** dialog window is illustrated in Figure 5.3.

Save

The **Save** command of the **File** menu will save the current project data in the **Project Data File**. If no file name for the current **Project Data File** has been defined, then the **Save** command will execute as the **Save As** command.

The **Save As** command of the **File** menu will query you for the file name of the **Project Data File** with the **Save As** dialog window. If you press the **Save** button the current project will then be saved as if the **Save** command was executed.

Save As Data Fields

File Name

The file name identifies the **Project Data File**. **Lineback** is compatible with long file and directory names that follow the Windows conventions. Some versions of the Windows operating environment will truncate the default *lineback* extension to the three letters *lin*, so we recommend that you explicitly add the *lineback* extension to the file name in the Save As dialog window.

File Type

Starting with version 4.0 of the **Lineback** program, the **Project Data File** is a binary file that can no longer be viewed or manipulated outside the **Lineback** program. Use the **Export** command to create a set of ASCII files that contain the major data for the current project. These files can then be manipulated outside the **Lineback** program with an ASCII text editor and then imported again into the **Lineback** program using the **Import** command.

Import...

The **Import** command of the **File** menu allows you to read project data saved in ASCII files with a version of the **Lineback** program earlier than 4.0, created with the **Export** command, or created manually outside the **Lineback** program with an ASCII editor.

Starting with version 4.0 of the **Lineback** program, the **Project Data File** is a binary file that can no longer be viewed or manipulated outside the **Lineback** program. Use the **Open** command to read project data files created with the **Save** command of version 4.0 or higher of **Lineback**. The default extension for **Lineback** project files is *lineback*, the default extension for the Lineback project files of previous versions or exported data files is *dat*.

The command then displays the **Open** dialog window, which is illustrated in Figure 5.7. The program will read the corresponding **Project Data File** (*.*dat*) and **Customer Data File** (*.*cus*), **Supplier Data File** (*.*sup*), **Depot Data File** (*.*dep*), and **Route Data File** (*.*rou*). It will also read the corresponding **Map Data File** (*.*map*) if a map file has been specified.

The **Project Data File** and the **Facility, Route and Map Data Files** can be created with any text editor or word processor capable of generating pure ASCII files or with the **Export** command. Since word processors usually insert special formatting codes into their regular document files, which cannot be read by the **Lineback** program, special care should be taken when using a word processor to generate a pure ASCII file. The project data file also should not contain any blank lines. Once these input files have been created, they can be used repeatedly by the **Lineback** program.

Export...

The **Export** command of the **File** menu will save the current project data in a set of ASCII files. The program will create the corresponding **Project Data File** (*.*dat*), **Customer Data File** (*.*cus*), **Supplier Data File** (*.*sup*), **Depot Data File** (*.*dep*), and **Route Data File** (*.*rou*). Once these data files have been created, they can be read by the **Import** command and by an ASCII editor. Not all program settings will be saved, but only the major project and facilities data.

Starting with version 4.0 of the **Lineback** program, the **Project Data File** created by the **Save** command is a binary file that can no longer be viewed or manipulated outside the **Lineback** program. Use the **Open** command to read project data files created with the **Save** command of version 4.0 or higher of **Lineback**. The default extension for **Lineback** project files is *lineback*, the default extension for the Lineback project files of previous versions or exported data files is *dat*.

Send...

The **Send** command of the **File** menu uses the electronic mail application installed on your computer to send the saved version of the current project as an attachment to an electronic mail message. It is recommended that the current project first be saved before using the **Send** command. The exact execution of this command will depend on which electronic mail application has been installed on your computer. This command will not be enabled if you do not have an electronic mail client installed on your computer.

Properties...

The **Properties** command of the **File** menu allows you to add project information, such as authors, subjects, keywords, and comments to the current project. The **Properties** command displays the **Properties Dialog Window** for the current document, which is illustrated in Figure 5.9. You can provide additional information in this dialog window about the current project.

Information on the individual data fields is given in **Properties Data Items** and information on the general function of the command is given in **Properties** command of the **File** menu.

Properties Data Items

Application

The name of the application creating this dialog window. In this case, **Lineback**. You cannot change this data field.

Project

The project name or title. This is the only place where the title of the current project can be changed after it has been initially entered in the **New Project** dialog window or was imported from the **Project Data** file.

Further information can be found in the Project Data section under Project Title.

Subject

The subject of the current project.

Author

The author of the current project.

Keywords

A list of one or more keywords describing this project.

Data Version

The data version of the current project. You cannot change this data field. It is displayed for information purposes only.

Comments

You can enter comments about the current project.

Output Log

The **Output Log** command of the **File** menu allows you to specify the file name for the log file created and used by the **Lineback** program. **Lineback** writes the results and intermediate information generated by the various design algorithms to the **Output Log file**. The amount of information written to the **Output Log File** depends on the level of detail selected with the **Report Level** command in the **Edit** menu. The file and all of its previous contents will be erased every time the **Output Log** command is executed. To select another log file or to restart the current log, execute the **Output Log** command again. To stop recording algorithm results without deleting the log file itself, use the **Close Log** command of the **File** menu.

Output Log Data Fields

File Name

The file name identifies the **Output Log File**. **Lineback** is compatible with long file and directory names that follow the Windows conventions.

File Type

The default output log file type is *log* and this type corresponds to a pure ASCII text file that can be viewed with a variety of text editors.

Close Log

Use this command to close the current output log. No further information or algorithm results will be written to the output log, but the output log file itself will not be deleted. Reopening the same log file with the **Output Log** command will

erase all the information in the log file, since the Output Log command always creates a new file.

Print

Use this command to print a document. This command presents a **Print** dialog window, where you may specify the range of pages to be printed, the number of copies, the destination printer, and other printer setup options.

You can also copy the all views to the clipboard with the **Copy** command of the **Edit** menu and then paste the views in other Windows applications.

Print Data Items

The following options allow you to specify how the current view should be printed:

Name

This is the active printer and printer connection. Choose the Setup option to change the printer and printer connection.

Properties

Displays a **Print Properties** dialog window, so you can select a printer and printer connection.

Print Range

Specify the pages you want to print: *Table 5.1. Print Range Options*

Option	Legend
All	Prints the entire document.
Selection	Prints the currently selected text.
Pages	Prints the range of pages you specify in the From and To boxes.

Copies

Specify the number of copies you want to print for the above page range.

Collate Copies

Prints copies in page number order, instead of separated multiple copies of each page.

Print Progress Dialog

The Printing dialog window is shown during the time that **Lineback** is sending output to the printer. The page number indicates the progress of the printing.

To abort printing, choose Cancel.

Print Preview

Use this command to display the active view as it would appear when printed. When you choose this command, the main window will be replaced with a **Print Preview** dialog window in which one or two pages will be displayed in their printed format. The toolbar of the Print Preview window offers you options to view either one or two pages at a time; move back and forth through the document; zoom in and out of pages; and initiate a print job.

Print Setup Data Items

The following options allow you to select the destination printer and its connection.

Name

Select the printer you want to use. Choose the Default Printer; or choose the Specific Printer option and select one of the current installed printers shown in the box. You install printers and configure ports using the Windows Control Panel.

Orientation

Choose Portrait or Landscape.

Paper Size

Select the size of paper that the document is to be printed on.

Paper Source

Some printers offer multiple trays for different paper sources. Specify the tray here.

Properties

Displays a dialog window where you can make additional choices about printing, specific to the type of printer you have selected.

Most Recently Used Files

Every time a project is saved, **Lineback** adds the fully qualified path and file name of the project data file to the list of the most recently used (MRU) files. The eight most recently used files are listed in the **File** Menu and saved in the Registry between sessions. You can bypass the Open command and open one of those projects directly by clicking on its file name.

Exit

The Exit command of the File menu terminates the Lineback program.

If there is a project currently open and if it has been modified, then the program will display the **Save Changes** dialog window and ask if you wish to save those changes, discard the changes, or if you wish to abort the termination of the application. The **Save Changes** dialog window is illustrated in Figure 5.3.

The **Lineback** program can be terminated in the same way as all Windows programs by double clicking on the system menu box or by selecting the **Exit** command.

Edit Menu

All the data items of the current project can be modified while executing the **Lineback** program. Most of the data items can be edited with commands from the **Edit** menu. Some overall project characteristics can be changed with commands on the **File** menu. Finally, some algorithm parameters can be changed with the commands on **Algorithms** menu.

Add Depot

The Add Depot command adds a depot to the current project. A project can only have a single depot, so if there is already a depot facility included in the project, then this command is disabled. Select the Add Depot command and the cursor will change to a crosshair shape. Move the cursor in the **Routes** view to the approximate location of the depot and click the left mouse button. The **Add Depot** dialog window will be displayed where you can specify additional data for this depot and refine the coordinates. The dialog window is shown in Figure 5.14. Press **Ok** to add this depot to the project. The number of depots in the **Notes** view is updated and the **Routes** view displays the depot.

Information on the individual data fields is given in **Depot Data Items** and information on the general function of the command is given in **Add Depot** command of the **Edit** menu.

Depot Data Items

Label

Each depot has a unique label. The label can only contain letters, digits, and underscore characters. The maximum length of the label is seven characters. The label is a required data item; i.e., it cannot be empty. The label will be used to identify the depot in all screen and dialog windows.

Description

Each depot has a description or name. The description can contain only letters, underscore characters, and spaces and the maximum length of the description is 63 characters. The description is a required data item; i.e., it cannot be empty.

Y Coordinate

The location of the supplier is given by its x and y coordinate or by its latitude and longitude, depending on if the orthogonal map projection is used for the project. The latitude is stored in the packed integer (+/-)dddmmss format. For example, the longitude 23°20'15" W is represented as -0232015, and the latitude 35°20'43" N as 0352043. The degrees, minutes, and seconds of the latitude or longitude are unpacked and then shown and edited separately in the first, second, and third field of the latitude or longitude line, respectively. Latitude and longitude in the packed integer format are described in more detail in the section on **Common Data Items**.

X Coordinate

The location of the supplier is given by its x and y coordinate or by its latitude and longitude, depending on if the orthogonal map projection is used for the project. The longitude is stored in the packed integer (+/-)dddmmss format. For example, the longitude 23°20'15" W is represented as -0232015, and the latitude 35°20'43" N as 0352043. The degrees, minutes, and seconds of the latitude or longitude are unpacked and then shown and edited separately in the first, second, and third field of

the latitude or longitude line, respectively. Latitude and longitude in the packed integer format are described in more detail in the section on **Common Data Items**.

Quantity

The customer delivery and supplier pickup quantity must be non-negative quantity less than the vehicle capacity. The depot has neither a linehaul delivery or a backhaul pickup quantity, so typically its quantity is set to zero. The depot quantity is not used in any of the route design algorithms.

Display Shape

The geometrical symbol or shape used to display the supplier in the **Routes** views. A list of all valid symbol names is given in the **Display Symbols** section of the **Common Data Items**.

Display Size

The size of the geometric symbol displayed in the **Routes** views.

Display Color

The color used to display the supplier symbol in the **Routes** views. A list of valid color names is given in the **Color** section of the **Common Data Items**.

Add Customer

The Add Customer command adds a customer to the current project. The maximum number of customers in a project depends on the version of **Lineback**. The addition process, dialog windows, and data items are complete analogous to the **Add Depot** command.

Add Supplier

The Add Supplier command adds a supplier to the current project. The maximum number of suppliers in a project depends on the version of **Lineback**. The addition process, dialog windows, and data items are complete analogous to the **Add Depot** command.

Add Random Facilities

The Add Random Facilities command allows you to add quickly a large number of facilities to the current project with random locations and random quantities. The **Add Random Facilities Dialog Window** will be displayed which allows you to specify the **Add Random Facilities Data Items**. The maximum number of new facilities for each type is the difference between the maximum number of facilities of that type in your version of **Lineback** and the number of facilities of that type already in the project. The facilities will be uniformly located inside the world boundary coordinates. You can specify a maximum quantity for each facility type. The facilities of that type will have quantities uniformly distributed between one and the respective maximum quantity. The random locations and quantities are generated with the random number seed that you specify.

Press **Ok** to add the indicated number of new facilities to the project. Press **Cancel** to cancel the dialog window and *not* to add facilities to the project.

Add Random Facilities Data Items

Number of Customers

The number of customers that you want to add to this project. The minimum number you can add is zero or no new customers. The maximum number you can add is the difference between the maximum number of customers for your version of **Lineback** and the number of customers already in the project.

Maximum Customer Quantity

The maximum delivery quantity for the customers that you want to add to this project. The customer's quantity will be uniformly distributed between one and the maximum quantity you specified. The maximum quantity can be no larger than the vehicle capacity.

Number of Depots

The number of depots that you want to add to this project. The minimum number you can add is zero or no new depots. The maximum number you can add is the difference between the maximum number of depots for your version of **Lineback** and the number of depots already in the project. Currently **Lineback** allows only a single depot in a project.

Maximum Depot Quantity

The maximum depot quantity is not used in the project and will be set to zero.

Number of Suppliers

The number of suppliers that you want to add to this project. The minimum number you can add is zero or no new suppliers. The maximum number you can add is the difference between the maximum number of suppliers for your version of **Lineback** and the number of suppliers already in the project.

Maximum Supplier Quantity

The maximum delivery quantity for the suppliers that you want to add to this project. The supplier's quantity will be uniformly distributed between one and the maximum quantity you specified. The maximum quantity can be no larger than the vehicle capacity.

Seed

This data item is the seed for the random number generator, which is used to generate the random samples of customer and supplier locations and quantities. The Add Random command will always generate identical additional facilities if you select the same number and maximum quantities of the facilities and set the same random number seed.

Edit Depot

The Edit Depot command allows you to change the data items of a depot already included in the current project. Select the Edit Depot command and the cursor will change to an up-arrow shape. Move the cursor in the **Routes** view to the depot symbol and click the left mouse button. The **Edit Depot** dialog window will be displayed where you can modify the data for this depot. The dialog window is shown in Figure 5.16. Please see the description of the **Depot Data Items** under the **Add Depot** command for further information on the data fields associated with this depot. Press **Ok** to confirm the changes you have made for this depot and update the project. Press **Cancel** to cancel the dialog window and *not* to change the facility data.

The Edit Customer command allows you to modify the data characteristic of an existing customer. The modification process, dialog windows, and data items are complete analogous to the **Edit Depot** command.

Edit Supplier

The Edit Customer command allows you to modify the data characteristic of an existing customer. The modification process, dialog windows, and data items are complete analogous to the **Edit Depot** command.

Edit Facility

The Edit Facility command allows you to modify the data characteristic of an existing facility regardless of its type. The modification process, dialog windows, and data items are complete analogous to the **Edit Depot**, **Edit Customer**, or **Edit Supplier** command, depending on the type of facility that you select.

Edit Depot by Label

The Edit Depot by Label command will display a list with all the labels of the current depot facilities in the project. The **Select Depot by Label Dialog Window** is illustrated in Figure 5.17. After a depot has been selected with its label, the depot data can be edited just like in the **Edit Depot** command by pressing the **Edit** button. While the **Edit Depot** dialog is shown, choose **OK** to retain the modified depot data and choose **Cancel** to cancel the dialog window and *not* to change the depot data. In either case, you are returned to the **Select Depot by Label** dialog window and can then select the next depot to be edited by its label. Pressing the **Done** button will terminate the depot selection dialog window.

The **Delete Depot** dialog window will be displayed where you can verify that this is the correct depot to be deleted. The dialog window is shown in Figure 5.18. Delete Customer

The Delete Customer command allows you to delete an existing customer from the project. The deletion process, dialog windows, and data items are complete analogous to the **Delete Depot** command.

Delete Supplier

The Delete Supplier command allows you to delete an existing supplier from the project. The deletion process, dialog windows, and data items are complete analogous to the **Delete Depot** command.

Delete Facility

The Delete Facility command allows you to delete an existing facility from the project regardless of its type. The deletion process, dialog windows, and data items are complete analogous to the **Delete Depot**, **Delete Customer**, or **Delete Supplier** command, depending on the type of facility that you select.

Delete Depot by Label

The Delete Depot by Label command will display a list with all the labels of the current depot facilities in the project in the **Select Depot by Label Dialog Window**. This dialog windows is illustrated in Figure 5.19. After you have selected a depot with its label, the depot can be deleted just like in the **Delete Depot** command by pressing the **Delete** button. When the **Delete Depot Dialog Window** is shown for the selected depot, choose **OK** to delete the depot and choose **Cancel** to cancel the dialog window and *not* to delete the depot. Edit Link

The algorithms from then on will use the distance that you specified until the distances are recomputed with the **Compute Distances** command. Press **Ok** to confirm the changes you have made to the distances and update the project. Press **Cancel** to cancel the dialog window and *not* to change the distances for this link.

Edit Link Data Items

Distance

The distances from the first facility of the pair to the second facility and form the second facility to the first facility. These distances may be different if you enabled asymmetric distances in the project. If asymmetric distances are disabled, then the

two distances will always be identical. The distance between a pair of facilities must be non-negative.

Allow Asymmetric Distances

If the distance between two facilities is different depending on the direction of the travel between the facilities, the distances are said to be asymmetrical. You must enable asymmetrical distances for the project, in order to allow the distances between a pair of facilities to be different.

All Distances

Use this command to display or edit all the distances between the facilities. The command will display the **All Distances** dialog window, which allows the modification of the distances. The All Distances dialog window is illustrated in Figure 5.22.

This dialog window shows the distances between the facilities. Each row represents an origin facility and each column represents a destination facility. You can use the scrollbars to move around the distance matrix, if there are more facilities than can be displayed simultaneously in the dialog window. You can also move the arrow keys to move around the distance matrix.

Double click on any distance and you will be able to modify that distance with the **Edit Distance** dialog window. You can also click on the **Edit** button or press **Alt-E** to edit the currently selected distance, which is indicated by a thin black border.

You can edit a distance as many times as you want and as many distances as you want.

When you have finished editing the distances, click on **OK** to accept the modifications that you have made to the distances. If you click on **Cancel** then all the modifications that you have made to the distances will be discarded and none of the distances will be modified.

Compute Distances

The Compute Distances command updates the distance between each pair of facilities based on the current facility location and using the currently specified distance norm. This command is most often used after you have modified the location of one or more facilities and you want to update the inter-facility distance so that they correspond to the new facility locations.

If you have modified manually the distance between one or more pair of facilities, then these modifications will be replaced by the newly computed distance.

Symmetric Distances

The Symmetric Distances command will make the distance between a pair of facilities symmetrical by copying the pairwise distance from above the main diagonal of the distance matrix to the corresponding element below the main diagonal.

If you have modified manually a distance between a pair of facilities below the main diagonal of the distance matrix, then these modifications will be replaced by the corresponding distance from above the main diagonal.

Delete All Routes

The Delete All Routes command allows you to delete all the routes from the current project. Because of its significant impact on the current project, a warning dialog





box is displayed to verify that you really want to delete all routes. The Delete All Routes Confirmation Dialog Window is illustrated in Figure 5.23.

Number of Vehicles...

The Number of Vehicles command displays the **Number of Vehicles Dialog Window**, which allows you to edit the number of vehicles available in the project to execute routes. It is assumed that each vehicle can execute at most one route, so the number of vehicles is an upper bound on the number of routes. The maximum number of vehicles is dependent on your version of **Lineback**.

Infeasibility Penalty...

The Infeasibility Penalty command displays the **Infeasibility Penalty Dialog Window**, which allows you to edit the infeasibility penalty factor. The infeasibility penalty factor is multiplied by the quantities of any unvisited facilities and by the quantity on each route that exceeds the vehicle capacity to compute the total infeasibility penalty. The total infeasibility penalty is then added to the total route distance to yield the total route cost. The infeasibility penalty factor must a nonnegative number. A more positive infeasibility factor increases the tendency of the algorithms to create more feasible routes.

Distance Norm...

If the project uses the orthogonal map projection, then the Distance Norm command displays the **Distance Norm Dialog Window**, which allows you to specify the distance norm used to compute the distance between every pair of facilities. For the orthogonal map projection, the available distance norms are rectilinear, Euclidean or Chebyshev. For the Mercator and Albers map projections, the great circle norm is always used and the Distance Norm command is disabled.

Report Level...

Report Level Data Items

Levels of Detail

There are six levels of detail and pauses for reporting:

- 0. NONE generates no output per algorithm and does not halt the algorithm execution. This level is used when maximum execution speed and minimal reporting is desired.
- 1. DATABASE generates one line of strictly numerical output per algorithm. No titles or headers are included. This level is primarily used to create a data base file, which can then be manipulated in a spreadsheet or statistical analysis program.
- 2. SUMMARY displays the total cost plus the algorithm run time. It is useful if you is only interested in the final results. This level of output should be used if you is interested in performing timing studies. Higher level of details corrupt timing results due to your interaction and graphics creation delays.
- 3. STANDARD generates the total cost for each of the algorithm components. The program runs without interruption until the complete algorithm is finished.
- 4. EXTENDED displays the total cost during each of the algorithm modules and the run time so far. The program halts frequently to allow you to observe the algorithm process.
- 5. DEVELOP generates extremely detailed output plus a very large number of intermediate results. This mode is only useful for debugging

purposes or to observe the most detailed workings of the algorithms. The output is extremely long for large problems.

Seed...

The **Seed** command of the **Edit** menu displays the **Seed** dialog window, which allows you to set the new seed for the random number generator. The route improvement algorithms based on simulated annealing use random numbers to select the next two facilities to be tested for a possible exchange. An algorithm will always produce the same identical results if you select the same algorithm settings and set the same random number seed.

Click on **OK** to accept the modifications that you have made to the random number seed. If you click on **Cancel** then all the modifications that you made to the random number seed will be discarded and the random number seed will not be modified.

Seed Data Items

Any positive seed value between 1 and 32767 is a valid starting seed for the random number generator. If a zero seed value is specified, the computer will create a random seed based on the computer clock.

Default

The default value for the seed is equal to one. This is the seed when the program is originally started.

Random

If a value of zero is entered for the seed, then the program will select a random seed based upon the computer clock.

Max. Replications...

The **Max. Replications** command of the **Edit** menu allows you to change the maximum number of replications of an algorithm. The default number of replications is equal to 20.

Click on **OK** to accept the modifications that you have made to the maximum number of replications. If you click on **Cancel** then all the modifications that you made to the maximum number of replications will be discarded and the maximum number of replications will not be modified.

Maximum Replications Data Items

Some non-deterministic route improvement algorithms need to make repeated random choices to identify facilities to be tested for a possible exchange. Different replications of the same algorithm can thus provide different routes. The higher the number of replications, the more likely it is that a good set of routes will be constructed. Of course, more replications require more computation time.

Time Limit...

The maximum time limit is the maximum amount of time a single algorithm is allowed to execute. The time limit is expressed in seconds. Click on **OK** to accept the modifications that you have made to the time limit. If you click on **Cancel** then all the modifications that you made to the time limit will be discarded and the time limit will not be modified.

If an algorithm exceeds the time limit, then you can either abort or continue the algorithm with the Time Expiration dialog window. At that time you have also the option to set a new time limit.

Time Limit Data Items

Currently, the time limit is only used to terminate the two, three and annealing exchange algorithms if they have exceeded the time limit after one complete

iteration, i.e. after all possible two or three exchanges have been tested or when the annealing temperature is decreased. So it is possible that the execution time of the improvement algorithm is actually larger than the time limit specified.

The **Copy** command of the **Edit** menu copies the contents of the currently active view to the Windows clipboard. Algorithms Menu

Nearest Neighbor

The Nearest Neighbor algorithm starts each route at the depot facility and then iteratively appends the nearest unvisited customer to the route. When appending the next customer would violate the truck capacity, the algorithm switches to iteratively appending the nearest unvisited supplier to the route. When appending the next supplier would violate truck capacity, then the route returns to the depot. If unvisited customers or suppliers remain and the maximum number of routes has not been reached, then a new route is started and the above process is repeated.

Nearest Neighbor Algorithm Shortcuts

Keys: CTRL+ALT+N

Sweep

The Sweep algorithm creates a sweep tour by appending the facilities to the tour when they are traversed by a ray rotating around the depot. The relative polar coordinates of each point with respect to the depot are determined and the points are inserted in the tour by increasing polar angle. The algorithm was first described by Gillet and Miller (1974) for the vehicle routing problem. The starting angle of the ray is an algorithm parameter.

This algorithm is extended in a straightforward manner to the case of vehicle routing with backhauls. When a customer or supplier facility is traversed by the rotating ray it is inserted between the most recently appended customer and supplier facility on that route. When the inserting either the next customer of supplier would violate truck capacity, then the route is terminated. If unvisited customers or suppliers remain and the maximum number of routes has not been reached, then a new route is started and the process is repeated.

The initial starting angle of the rotating ray is an algorithm parameter that you can specify on **Sweep** tab of the **Select** command of the **Algorithms** menu.

Sweep Algorithm Shortcuts

Keys: CTRL+ALT+S

Savings

The Savings algorithm executes the Clarke and Wright (1964) construction procedure that extends a partial route or route primitive at its two end points. Conceptually the algorithm constructs an Eulerian tour that visits each of the customer and suppliers and the returns to the depot. The Eulerian tour is then reduced in length by finding and executing the shortcut with the largest savings. Deif and Bodin (1984) delayed the crossover link between customers and suppliers on each route by reducing the savings of establishing a short cut between a customer and supplier by the product of the savings penalty factor and the largest savings of any pair of points.

This savings penalty factor is an algorithm parameter set by the user. Deif and Bodin found that a good value for the savings penalty factor is 0.25. You can set the savings penalty factor on the **Savings** tab of the **Select** command of the **Algorithms** menu.

Savings Algorithm Shortcuts

Keys: CTRL+ALT+V

Extreme Crossovers

The Extreme Crossovers algorithm creates a number of partial routes with on each route a single customer and a single supplier. It matches the customer and supplier that have the largest savings if they were visited on single route instead of on separate routes. This is the same savings definition as used by Clarke and Wright in the **Savings** algorithm. The number of routes is equal to the minimum of the number of vehicles, the number of customers, and the number of suppliers.

Extreme Crossovers Algorithm Shortcuts

Keys: CTRL+ALT+X

Manual

The **Manual** command allows you to construct a set of feasible routes in an interactive manner. When you execute the **Manual** command, the cursor changes to a vertical arrow indicating that you can now select facilities to be added to the routes

and the algorithm Abort button on the tool bar is enabled. You start by clicking the left button of the mouse when it is over the depot and extend the routes by clicking the left button of the mouse when the cursor is over an unvisited or free facility. If you click for the second time on the depot, then the route is closed. Once a supplier or backhaul facility has been added to the route, you can not longer add customer or linehaul facilities to the current route. If adding the customer or supplier would violate the vehicle capacity, then that facility is not added to the route. The algorithm terminates when either all facilities have been placed on a route or the number of routes is equal to the number of vehicles. Not all facilities have to be included on the routes when the algorithm terminates, in other word, partial routes or route primitives are allowed.

If you click again on the last facility of the current route, then this point is removed from the route and becomes free again and the next to last facility on the route becomes the last facility. If the depot is the only facility on the route and is clicked again, then the complete route is removed. Clicking then again on the depot will make the depot the starting point of a new route. If the removed facility was the first backhaul supplier on the route, then you can add again linehaul customers to the route.

In general, clicking on a free facility adds this facility to the route if this is a feasible extension of the route and clicking on the last point of the route removes this facility from the route. Clicking on intermediate points of the route has no effect.

You stop the process of manually creating routes by pressing the **Escape** key. If the last facility on the current route is the depot then the algorithm terminates and route statistics are computed. If the last facility was not the depot, then the current route is closed by appending the depot facility and finally the route statistics are computed.

You can abort the Manual construction algorithm by pressing the **Abort** button on the toolbar, which is shown as a stop sign. The current set of routes is deleted and the algorithm statistics are not updated.

Manual Algorithm Shortcuts



Cheapest Insertion

The Cheapest Insertion algorithm inserts the remaining free facilities into the currently existing partial routes. The algorithm finds for every free facility the link on the routes with the smallest insertion penalty for that facility, provided the insertion would not make the route infeasible. It then inserts next the facility with the smallest of these insertion penalties and then updates the insertion penalties. Let F be the set of free facilities and T be the set of links on the routes, then the point k that is inserted next is given by

$$\min_{k \in \mathbf{F}} \left\{ \min_{(i,j) \in \mathbf{T}} \left(c_{ik} + c_{kj} - c_{ij} \right) \right\}$$

The algorithm thus executes a mini-min operation.

Cheapest Insertion Algorithm Shortcuts

Keys: Ctrl+Alt+C

Priciest Insertion

The Priciest Insertion algorithm inserts the remaining free facilities into the currently existing partial routes. The algorithm finds for every free facility the link on the routes with the smallest insertion penalty for that facility, provided the insertion would not make the route infeasible. It then inserts next the facility with the largest of these insertion penalties and then updates the insertion penalties. Let F be the set of free facilities and T be the set of links on the routes, then the point k that is inserted next is given by

 $\max_{k \in \mathbf{F}} \left\{ \min_{(i,j) \in \mathbf{T}} \left(c_{ik} + c_{kj} - c_{ij} \right) \right\}$

The algorithm thus executes a maxi-min operation.

Priciest Insertion Algorithm Shortcuts

Keys: Ctrl+Alt+P

Two Exchange

The 2-opt Exchange algorithm is an intra-route edge-exchange improvement procedure that operates on a single route at the time. It attempts the change the sequence of the facilities in a route so that the route length is reduced by removing two links of the route and replacing them with two other links that connect the route again. All pairs of links that would yield a feasible exchange are tested and the exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms. An exchange is infeasible if it would violate the precedence constraint that all deliveries to customers have to be made before any pickup from a supplier can be made.

Two Exchange Algorithm Shortcuts

Keys: Ctrl+Alt+2

Or Exchange

The Or-opt Exchange algorithm is an intra-route edge-exchange improvement procedure that operates on a single route at the time. It attempts the change the sequence of the facilities in a route so that the route length is reduced by removing a section or chain of the route and inserting this chain in a different place on the route. Moving a chain involves deleting three links of the route and replacing them with three other links that connect the route again. The number of facilities on the chain is called the length of the chain and is a parameter that you can specify. All chains of a certain length that would yield a feasible exchange are tested and the exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms. Since the Or-exchange involves removing three links and substituting them with three other links, all chain exchanges of all lengths will also be tested by the three-exchange procedure. An exchange is infeasible if it would violate the precedence constraint that all deliveries to customers have to be made before any pickup from a supplier can be made.

Or Exchange Algorithm Shortcuts

Keys: Ctrl+Alt+O

Three Exchange

The 3-opt Exchange algorithm is an intra-route edge-exchange improvement procedure that operates on a single route at the time. It attempts the change the sequence of the facilities in a route so that the route length is reduced by removing three links of the route and replacing them with three other links that connect the route again. All triplets of links that would yield a feasible exchange are tested and the exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms. An exchange is infeasible if it would violate the precedence constraint that all deliveries to customers have to be made before any pickup from a supplier can be made.

Three Exchange Algorithm Shortcuts

Keys: Ctrl+Alt+3

Move

The Move Facility procedure attempts to reduce the combined length of all the routes by moving a single facility from one route to another, provided the resulting routes remain feasible. A route can become infeasible if either the linehaul or backhaul quantity exceeds the truck capacity or if the precedence constraint is violated that states that all deliveries to customers have to be made before any pickup from a supplier can be made. All move exchanges are tested and the move exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms.

Move Algorithm Shortcuts

Keys: Ctrl+Alt+M

Swap

The Swap Facility procedure attempts to reduce the combined length of all the routes by moving one facility from one route to another and simultaneously move one facility from the second route to the first route, provided the resulting routes remain feasible. A route can become infeasible if either the linehaul or backhaul quantity exceeds the truck capacity or if the precedence constraint is violated that states that all deliveries to customers have to be made before any pickup from a supplier can be made. All swap exchanges are tested and the swap exchange with the largest positive savings is executed. The algorithm thus belongs to the class of steepest descend improvement algorithms.

Swap Algorithm Shortcuts

Keys: Ctrl+Alt+W

Select

The Select command allows you to specify an algorithm, to set the parameters for this algorithm, and to execute this algorithm. Only algorithms that take additional

parameters will be displayed as one of the tabs in this dialog window. At the current time the **Sweep**, **Or Exchange**, and **Savings** algorithms have parameters that can be changed by you and are displayed as tabs.

For the Sweep algorithm you can specify the starting angle of the rotating line segment. For the Or Exchange algorithm you can specify the number of facilities on the route chain that will be evaluated for relocation. For the Savings algorithm you can specify the penalty factor by which the savings are reduced when going from a delivery customer to a pick-up supplier.

Evaluate

The **Evaluate** algorithm computes the length and the cost of the current routes. The **Evaluate** command does not create new routes, but rather computes the length and the cost of the current routes based on the current distances, supply and demand data, number of vehicles and vehicle capacity, and infeasibility penalty. The results are displayed in the **Notes** and **Statistics** views and in the Evaluate algorithm dialog window. This algorithm is most frequently used after you have edited interactively the distances, the facility, or the vehicle data to evaluate the impact of the changes you have made.

All settings and switches in the View menu apply only to the currently active view. The equivalent setting in other views will not be affected by the commands of this menu.

Grid

The **Grid** command is a toggle switch which displays or hides the orthogonal grid in the **Routes**. This grid is primarily of use when you want to move one or more of the points by dragging them in the **Routes** view. The distance between two grid lines and the size of the unit squares in the **Routes** view can be changed with the **Grid Size** command of the **View** menu.

Click on **OK** to accept the modifications that you have made to the grid size. If you click on **Cancel** then all the modifications that you made to the grid size will be discarded and the grid size will not be modified.

Zoom

The **Zoom** command allows you to select a rectangular portion of the current **View** window and to enlarge that rectangular region so that it will fill the complete **View** window. After the command has been selected you start a rubber band bounding rectangle by pressing and holding down the left mouse button in any **Routes** view. The rectangle will shrink or grow following the cursor until you release the left mouse button. The **Zoom** operation preserves the length to width aspect ratio of the **View** window. The zoom option is most useful to display the routes in more detail. The full, original **View** can be displayed by using the **Zoom Previous** command. The previous **View** screen can be viewed by using the **Zoom Previous** command.

New Routes Window

The **New Routes View** command adds a new window that displays the hexagonal adjacency graph of the current project. The display options for the new view are the standard options. You can then modify these options in the normal fashion described under the **Display** menu. Each **View** window can be moved and sized to suit your taste.

Cascade

This command cascades or arranges all child views in an overlapping manner, with the currently active child view on top.

Tile

This command tiles or arranges all child views in a non-overlapping manner, attempting to make each view window the same size.

Arrange Icons

This command arranges all icons of child views that have been minimized at the bottom of the **Lineback** window.

Opened Windows

You can activate any of the opened view windows by clicking on its name in the Window menu or by clicking anywhere in the window area. When you activate a window it displayed on top of all other child view windows.

Toolbar

This command toggles the display of the toolbar of the **Lineback** program. The toolbar contains short cut buttons to the most commonly used commands. When the mouse point is held immobile for a short time on any button of the toolbar a tool tip which gives the buttons functions will be displayed.

Vigo and Toth Case 51-80

This case was first described by Eilon in the framework of the classical Vehicle Routing Problem (VRP). The problem contained 50 linehaul customers and a depot. This corresponds to a total of 51 facilities which is the first segment of the number in the case name. Vigo and Toth converted this problem to a linehaul-backhaul or Vehicle Routing Problem with Backhauls (VRPB) by randomly assigning 80 % of the points to be linehaul customers and 20 % of the points to be backhaul suppliers. The 80 % corresponds to the second part of the number in the project name.

Glossary of Terms

ASCII

ASCII is an acronym in computer science for American Standard Code for Information Interchange. It is a standardized coding scheme that assigns numeric values to letters, numbers, punctuation marks, and certain other characters. By standardizing the values used for these characters, ASCII enables computers and computer programs to exchange information. ASCII provides for 256 codes divided into two sets of 128 each. The standard ASCII character set consists of the first 128 codes. The first 32 values of standard ASCII are assigned to communication and printer control codes, i.e., non-printing characters, such as backspace, carriage return, and tab, that are used to control the way information is transferred from one computer to another or from a computer to a printer. The remaining 96 codes are assigned to common punctuation marks, the digits 0 through 9, and the uppercase and lowercase letters of the Roman alphabet. Since ASCII characters just consists of characters, numbers, and punctuation marks and none of the special formatting codes associated with word processors, most programs are able to read ASCII files. Common synonyms are "DOS text" or "text".

GUI

GUI is the abbreviation for graphical user interface. **Lineback** follows the conventions of the standard Windows user interface.

MRU

MRU is the abbreviation for Most Recently Used. Most applications display a list of most recently used files in their File menu to allow quick access to the project and document files that have been recently saved.

RGB

RGB is an acronym for Red-Green-Blue and it denotes a color described by three numbers for its red, green, and blue components, respectively. Windows allows values from 0 to 255 for each component for a total of more than 16.7 million colors.

Scientif

Scientif is a library containing common scientific functions used in Windows programs. The current implementation is *scienmfc.dll*, which is the 32-bit dynamic link library required to run the **Lineback** application program. **Scientif** in turn requires a 32-bit Windows operating system, which is denoted by Win32. The safest location for *scienmfc.dll* is in the directory where **Lineback** was installed. For the 32-bit Windows NT operating system *scienmfc.dll* can also be placed in the system32 directory of the directory where Windows NT has been installed. Usually this directory is *c:\winnt\system32*. For the Windows 95 and 98 operating systems *scienmfc.dll* can also be placed in the system directory of the directory where Windows 95 or 98 has been installed. Usually this directory is *c:\windows\system*. The automated **Setup** program with its default selections will place all the application and library files in the appropriate directories.

Setup

Setup is the automated, Windows based installation program which copies the **Lineback** program, help, libraries, and example data files to your hard disk. In addition, it installs **Lineback** in the selected program group on your desktop. The **Setup** program file is *setup.exe* and it is located on the first distribution diskette or CD-ROM.

Win32

Lineback is a 32 bit Windows program and as such requires a 32 bit version of the Windows operating environment, denoted by Win32. Current implementations of Win32 are Windows NT (all versions) and Windows 95 and 98 (all versions). This version of **Lineback** is no longer compatible with the 32 bit extensions Win32s to the 16 bit Windows 3.1.

www

WWW is the acronym for the World Wide Web and denotes the collection of sites on the Internet that contain a large variety of information.
